The winner of Grades K-2 was Ellie Kim who received a \$50 gift certificate, the winner of Grades 3-5 category was Jake Scoropanos who received a \$50 gift certificate and the winner of the Grades 6-8 category was Ashley Park who received a \$50 gift certificate. Commissioner Key said the prizes were generously donated by the Chamber of Commerce. Green Team Task Force Member JR Frank will make a collage of all the T-shirt submittals and they will be placed at each of the schools. Also, the WEC would like to thank Fran Piskadlo, Environmental Commission Liaison, for her organizational skills and knowledge of this TUTU event which she efficiently coordinates each year.

- **SHREDFEST** - Saturday, April 8, 2017 – Update  
Chair Wiederhold said this event was also a success. Approximately 325 residents deposited their personal documents for shredding which resulted in approximately 10,000 pounds or six tons of shredded recycled paper. Many volunteers, including the CERTS, helped along with the Wyckoff Environmental Commissioners.
- **FLOW FILM FESTIVAL** – Update  
Chair Wiederhold said the 2 final films were shown. Thank you to Library Director Laura Leonard for helping to orchestrate “The Highlands Rediscovered” film at the Wyckoff Library along with a discussion from Ridgewood Water Director of Operations Rich Calbi. Also, a special thank you to JR Frank who organized the 4 FLOW films for the 2017 film festival.
- **FISHING DERBY** – June 3, 2017 – Arrive at 8:00 a.m. to Zabriskie Pond Park  
Chair Wiederhold said volunteers are needed. The 2 Junior Members will attend this event. This is a catch and release event for young anglers 14 years old and younger. Fran Piskadlo, Environmental Commission Liaison, will assist the Commissioners with organizing the stocking of Zabriskie Pond and purchasing the prizes for the 3 age categories. This event is coordinated with Wyckoff Day.
- **WYCKOFF DAY** – June 3, 2017 – 10:30 a.m. to 4 p.m. – Registration deadline is April 15  
Chair Wiederhold said the WEC has registered for this event. Township Committeeman Madigan said Wyckoff Day will kick off with a Mayor’s Wellness Walk around Pulis Field. Commissioner Key said ANJEC will supply the WEC booth with family and festival energy games for Wyckoff Day.
- **WELCOME 2017 JUNIOR COMMISSIONERS** Nick Rea & Dan O’Connell. Also Green Team Member Julia Alfano  
Nick Rea, a student at Bergen Academies and Dan O’Connell, a student at Ramapo High School, will be the new Junior Members of the Wyckoff Environmental Commission. The Commissioners warmly welcomed the 2 newest members. Commissioner McCauley asked Nick and Dan what their projects will be this year. Dan said his project will be climate change. Nick will advise the Commissioners at the next meeting what his project will be. Green Team Member Julia Alfano will assist the Commissioners with the Natural Resource Inventory Project.
- **PROPOSED WATER SYMPOSIUM** with Ridgewood Water for Wyckoff residents – discussion  
Commissioner Key said this symposium was combined with the film festival. Agra is the company that will analyze the water collected by the residents at a small cost to the resident.

- **“WASTE IT ONCE, PAY FOR IT TWICE”** – Public information program to encourage recycling. This program was identified in the April 2017 community newsletter of the Township of Wyckoff and get more people action oriented. Ideas and volunteers are requested.
- **RECYCLOMETER** – Update  
Commissioner Key said the recyclometer reading for March is 31.18%. February’s reading was 35.05%.
- **ONLY RAIN IN THE DRAIN** – This is a public information program to discourage littering, pet waste and people pollution. Ideas and volunteers are requested.
- **DON’T TREAT YOUR RECYCLABLES LIKE TRASH! Recycle, recycle, recycle** – This is the Township’s primary public information effort to persuade residents to help the other township residents reach the “nifty-fifty” (the State of New Jersey’s mandate for each municipality to recycle 50% of their waste). Ideas requested.
