- 1. Mr. Boonstra welcomed all to the meeting and thanked everyone for their willingness to serve on the Commission.
- 2. Robert Shannon, who is also serving as the Deputy Municipal Clerk, administered the Oath of Office to members of the Historic Preservation Commission.
- 3. All Historic Preservation Commission members introduced themselves and provided their interest and background relative to historic preservation.
- 4. Ordinance #1875 which creates the Historic Preservation Commission and ordinance # 1876 which guides the actions of the Historic Preservation Commission were distributed, explained and discussed. Various aspects of historical preservation were also discussed including; the percentage of a structure that has historical value, how to discourage demolition of homes with historic characteristics, how the Commission can assist owners of historic homes such as providing a list of contractors with legitimate expertise and experience in historic construction methods and how to document historic homes and list them on a map.
- Various methods to promote historic preservation and to raise citizen awareness were discussed, including a monthly post/article for the Suburban News and Wyckoff's social media accounts.
