WHEREAS, pursuant to N.J.S.A. 40A:4-41, a municipality must include an appropriation for "Reserve for Uncollected Taxes" in its annual budget where less than 100% of current tax collections may be and are anticipated; and,

WHEREAS, receipts from the collection of taxes levied or to be levied in the municipality and payable in the fiscal year shall be anticipated in an amount which is not in excess of the percentage of taxes levied and payable during the next preceding fiscal year which was received in cash by the last day of the preceding fiscal year; and,

WHEREAS, if tax appeal judgements of the county tax board pursuant to R.S. 54:3-21 et seq. and/or the State tax court pursuant to R.S. 54:48-1 et seq. result in tax reductions for the previous fiscal year, the governing body of the municipality may elect to calculate the current year reserve for uncollected taxes by reducing the certified tax levy of the prior year by the amount of the tax levy adjustments resulting from those judgements; and,

WHEREAS, Current Taxes – 2025 Levy of the Township's Annual Financial Statement for the year 2025 reflects reductions due to tax appeals of \$5,640.38 which when reduced from the 2025 tax levy results in the 2025 tax collection rate being 99.44 percent; and,

WHEREAS, the election of this choice to calculate the "Reserve for Uncollected Taxes" for the 2026 Municipal Budget shall be made by resolution approved by a majority of the full membership of the governing body prior to the introduction of the 2026 Municipal Budget pursuant to N.J.S.A. 40A:4-5.




WHEREAS, coverage was bound effective February 10, 2026, and the Township Committee wishes to ratify that action; and


WHEREAS, the Township also received a comparative quote from Chubb at \$11,381.00, and the 2024 Bollinger premium was \$13,374.00.

WHEREAS, the Township of Wyckoff (the "Township") requires specialized legal services for the calendar year; and

WHEREAS, the Township Committee has determined the necessity to engage an attorney with extensive expertise in insurance law and demonstrated professional competence; and

WHEREAS, Dermot J. Doyle, Esq. of the firm Huntington and Bailey, LLP has been selected based on their substantial legal experience in insurance law, previous satisfactory engagements with the Township and similar municipalities, and their authorization to practice law in the State of New Jersey; and

WHEREAS, the Township Administrator/Qualified Purchasing Agent and the Chief Financial Officer have determined that the anticipated cost for these services may exceed \$17,500, and it is deemed prudent to prepare for expenditures exceeding this sum to ensure compliance with the provisions of N.J.S.A. 19:44A-20.5 *et seq.*; and

WHEREAS, Huntington and Bailey, LLP has provided a Business Entity Disclosure Certification that confirms no reportable contributions exceeding \$200 were made to any municipal political or candidate committee in Wyckoff in the preceding year, and commits not to make such contributions during the term of the contract; and

WHEREAS, the Township Committee wishes to award a one-year professional services contract in accordance with the alternative procedure outlined in N.J.S.A. 19:44A-20.5; and

WHEREAS, pursuant to N.J.S.A. 40A:11-5, the Local Public Contracts Law mandates that resolutions authorizing the award of contracts for professional services without competitive bids, and the contracts themselves, be made publicly available; and

WHEREAS, the Chief Financial Officer has executed a Certification of Availability of Funds confirming that sufficient funds are appropriated in the 2026 Municipal Budget under the line item for legal services and related expenses.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wyckoff, located in the County of Bergen, State of New Jersey, that:



This appointment is made pursuant to the exemption from competitive bidding under the provisions of the Local Public Contracts Law regarding "Professional Services" as authorized by law and regulated by law in accordance with N.J.S.A. 40A:11-1 *et seq.*, and as per the alternative process allowed by N.J.S.A. 19:44A-20.5.

5. The Municipal Clerk shall publish a notice of this appointment in the Township's official newspaper as required by law.



AN ORDINANCE AMENDING THE LAND USE ORDINANCE OF THE TOWNSHIP OF WYCKOFF TO AMEND CHAPTER 186, ZONING, TO ADD ONE NEW INCLUSIONARY ZONE CONSISTENT WITH AND DESIGNED TO EFFECTUATE THE TOWNSHIP'S ADOPTED 2025 FOURTH ROUND HOUSING ELEMENT AND FAIR SHARE PLAN

WHEREAS, the Township of Wyckoff Planning Board Adopted a Fourth Round Housing Element and Fair Share Plan on June 25, 2025, in accordance with the Fair Housing Act, N.J.S.A.52:27D-301 et seq;

WHEREAS, the Township Committee of the Township of Wyckoff endorsed the Fourth Round Housing Element and Fair Share Plan via Resolution #25-188 on July 15, 2025;

WHEREAS, the Township of Wyckoff Fourth Round Housing Element and Fair Share Plan set forth that Block 483, Lots 38.01 and 46 shall receive zoning to permit inclusionary development in order to satisfy a portion of Wyckoff's constitutional obligation to provide for its fair share of low-and moderate income housing;

WHEREAS, the amended zoning of Block 483, Lots 38.01 and 46 herein is consistent with the Fourth Round Housing Element and Fair Share Plan;

WHEREAS, the SF/AH4: Single Family Affordable Housing Zone 4 will follow the property lines of Block 483, Lots 38.01 and 46; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wyckoff, Bergen County, New Jersey, that the Code of the Township of Wyckoff is hereby amended to include provisions for new zoning to permit residential inclusionary development on Block 483, Lots 38.01 and 46.

SECTION 1. Amend Section 186-3 Zoning Map to add a new Section Z. as follows:
Additions are shown as thus; deletions shown as ~~thus~~

II. The SF/AH4: Single Family Affordable Housing Zone 11 is the name of the zone established to include Block 483, Lots 38.01 and 46.

SECTION 2. Amend Section 186-49 Zoning districts and bulk requirements as follows:

Additions are shown as thus; deletions shown as ~~thus~~

M. SF/AH4: Single Family Affordable Housing Zone 4

(1) Principal permitted uses shall be as follows:

(a) Single-family detached housing.

- (2) Accessory Uses shall be those permitted in the MF/AH Zones as well as public open space in a cluster design as required by § 186-49L(5)(b).
- (3) Accessory buildings shall comply with the setback requirements of the R-15 zone district.
- (4) Conditional uses shall be as follows:
 - (a) Two-family attached housing.
 - [1] These units shall be for the provision of affordable housing in accordance with the required set-aside as set forth in § 186-49L(7) with the condition that both units must be affordable.
- (5) Bulk Requirements.
 - (a) Single-family and two-family lots permitted at a density of 3.33 dwelling units per acre in accordance with the following bulk requirements.

<u>Minimum Lot Size (square feet)</u>	<u>Average Lot (square feet)</u>	<u>Maximum Height (stories/feet)</u>	<u>Minimum Front Yard</u>

- (6) Minimum Off-Street Parking: as required by the Residential Site Improvement Standards.
- (7) Minimum affordable housing requirements for each site.
 - (a) Where the affordable units shall be for sale, 20% of the total units on the site shall be reserved for affordable housing.
 - (b) Where the affordable units shall be for rent, 15% of the total units on the site shall be reserved for affordable housing.
 - (c) Affordable housing units shall comply with the Township's affordable housing regulations and the Uniform Housing Affordability Control Rules (N.J.A.C. 5:80-26.1), which shall control in the case of any conflicts with this ordinance, provided that a minimum of 13 percent of the total low-and moderate-income units shall be affordable to very low income households (i.e. 30% or less of median income).

- (d) The affordable units shall be managed by a single entity in accordance with an Affordable Housing Management Plan, which shall be approved by the Township of Wyckoff, Affordable Housing Committee or other Township designated Administrative Agent.
- (e) The exterior design of affordable housing units shall be harmonious in scale, texture and materials with market-priced units.

(8) **Landscape and Screening Standards:**

- (a) A landscape plan shall be submitted with each application for development in accordance with § 223-5 of the Township Code.
- (b) The landscape plan shall include rain garden where possible to assist in the natural drainage of the site.
- (c) Exterior utility boxes, mechanical and electrical equipment, and HVAC equipment shall be screened from view by architectural elements and/or landscape plantings.

(9) **Miscellaneous Requirements:**

- (a) Sidewalks shall be required in accordance with the Residential Site Improvement Standards.
- (b) Signs shall be permitted pursuant to regulations in §186-28.

SECTION 3. Except as hereby amended, all other sections of Chapter 186 shall remain in full force and effect.

SECTION 4. This Ordinance shall take effect upon final passage and publication according to law.

**AN ORDINANCE TO AMEND CHAPTER 157 OF THE CODE OF THE TOWNSHIP OF
WYCKOFF, SEWERS, BY AMENDING SECTION 157-62, SCHEDULE OF
CHARGES, ESTABLISHING 2026 SEWER CHARGES FOR THE USE OF THE
SANITARY SEWER SYSTEM OF THE TOWNSHIP**

BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, in the County of Bergen, State of New Jersey, as follows:

SECTION 1. Chapter 157, Sewers, Article XI, Section 157-62, Schedule of Charges, is hereby amended in part to read as follows: [strike-through indicates deleted text and underlining indicates added text]

- A. The sewer service charge hereby established for 2025 2026, and thereafter, unless modified by ordinance, shall be sufficient to:
 - (1) cover all the charges, costs and expenses related to the sewer service, such as, but not limited to, the charges of the Northwest Bergen County Utility Authority, the charges of the Boroughs of Midland Park and Waldwick, pump stations and ejector station operation and maintenance costs, and all the costs incurred by the Township of Wyckoff in collecting its sewer service charges; and,
 - (2) create a reasonable reserve for maintenance and repairs.
- B. The sewer service charge shall be an annual charge commencing upon the date upon which a building connection is approved by the Township, and such charge shall be on the following basis and this rate shall stay in effect until subsequently modified by ordinance amendment:

SECTION 2. Except as hereby amended, Chapter 157 is hereby ratified and reaffirmed and shall continue in full force and effect.

SECTION 3. The invalidity of any section or provisions of this amendment to the ordinance shall not invalidate any other sections or provisions thereof.

SECTION 4. This ordinance shall take effect upon passage and publication as required by law.
