WHEREAS, the Township Committee adopted resolution #15-196 on July 21, 2015, authorizing an application to join the HGAC National Purchasing Consortium; and,

WHEREAS, the Township of Wyckoff is now a member of the Houston-Galveston Area Council (HGAC) purchasing program, a national purchasing cooperative; and,

WHEREAS, HGAC published legal notice advertisements soliciting sealed competitive bids in the May 7, 2017 and May 14, 2017 issue of the Houston Chronicle; and,

WHEREAS, on August 10, 2017 at 2:00pm competitive sealed bids were publicly opened and then their contents read aloud for the purchase of fire apparatus; and,

WHEREAS, the HGAC on January 3, 2018 assigned multiple contracts for the purchase of fire apparatus via contract #FS12-17 for the period December 1, 2017 thru November 30, 2019; and,

WHEREAS, P.L. 2011 c139 (the "Law" or "Chapter 139") allows local contracting units to utilize national cooperative contracts as a method of procurement; and,

WHEREAS, the New Jersey Department of Community Affairs, Division of Local Government Services (DLGS) has published LFN 2012-10, a Local Finance Notice detailing guidance to contracting units desiring to purchase under the Law; and,

WHEREAS, the Township Administrator, Fire Chief and Public Works Manager are satisfied that the procurement conducted by HGAC and the contract awarded to Spartan Motors USA, Inc. with the associated documentation submitted by both HGAC and Spartan Motors USA, Inc. are compliant with the guidance in LFN 2012-10; and,

WHEREAS, the Township of Wyckoff published a notice of intent to award contract in the February 22, 2019 edition of the Ridgewood News, (the Township's designated official newspaper for legal notices) and posted the notice on its website Wyckoff-nj.com at the legal notice section and posted the notice on its bulletin board in Town Hall where notices are customarily posted; and,

WHEREAS, at the conclusion of notice period (3/4/19 at 10:00 a.m.) no comments were received; and,

WHEREAS, a total purchase price for the fire apparatus is \$639,940.00; and,

WHEREAS, a cost savings determination in accordance with LFN-2012-10 has been performed resulting in a cost savings based on; the allowable standard **"most advantageous to the Township of Wyckoff price and other factors considered"** as compared to other apparatus prices from the HGAC National Cooperative Contract; and,

WHEREAS, the Chief Financial Officer has issued a certificate of available funds indication that sufficient funds exist in Capital Ordinance #1871 for this purchase; and,

WHEREAS, the Township Attorney has reviewed this procurement and concurs with the procurement action through this national cooperative contract since the purchasing agent followed the guidance from the State of New Jersey provided in LFN 2012-10.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey as follows:

1. The Township of Wyckoff is authorized to purchase from the HGAC National Cooperative Contract.
2. After a careful and thorough consideration of **“most advantageous to the Township of Wyckoff price and other factors considered”** the HGAC proposal submitted by Spartan Motors USA, Inc. in accordance with HGAC Contract #FS12-17 in amount of \$639,940.00 is hereby accepted.
3. The Township Administrator is hereby authorized to issue a purchase order to Spartan Motors USA, Inc., 907 7th Avenue North, Brandon, North Dakota 57005 in the amount of \$639,940.00 consisting of the base apparatus and unit price options provided in the HGAC bid specification totaling \$609,971.00 and apparatus unit items not provided for in the bid specification totaling \$31,469.00 or 5.15% authorized by resolution #2019-148 and the HGAC Service Fee and Trade-in Credit.
4. This procurement is in compliance with New Jersey's Play to Pay Law; both fair and open and alternate methods.
5. This contract, consistent with the HGAC contract and NJSA 40:A11-36(7) includes a trade-in for the existing 1966 Mack Fire Pumper at the time of delivery of the 2019 pumper as authorized by Resolution #19-118.

WHEREAS, the Township of Wyckoff conducts the annual Memorial Day Parade to honor our nation's war dead: and,

WHEREAS, this year's parade is scheduled for Monday, May 27, 2019; and,

WHEREAS, the marchers will assemble at the Cornerstone Christian Church (495 Wyckoff Ave.) and march left out of the church parking lot onto Wyckoff Avenue, proceed up Wyckoff Avenue and make a right on Main Street, march to the end of Main Street, make a right onto Franklin Avenue and left into Scott Plaza at Town Hall. The parade ends behind Town Hall at Fire Company #1; and,

WHEREAS, in the interest of safety and convenience for motorists and pedestrians, the following roadways will be closed for a limited time during the course of the parade – a portion of Wyckoff Avenue from the Cornerstone Church to Main Street, Main Street and Franklin Avenue in front of Town Hall; and,

WHEREAS, Bergen County was contacted for the closing of the Bergen County roads in the parade route and the Township was instructed to include the Bergen County roads in the Township road closing resolution.

Transportation Choices - We pledge to promote transportation choices, considering all modes of transportation, including walking, biking, transit and automobiles, when planning transportation projects and reviewing development applications. We will continue to evaluate our parking with the goal of ensuring adequate parking spaces while promoting shared parking and other innovative parking alternatives, and encouraging parking alternatives where appropriate.

WHEREAS, the Township of Wyckoff desires to develop a grounds maintenance program; and,

WHEREAS, this policy encourages, wherever practical, sustainable municipal operations and incorporates best practices of efficient landscape design, water conservation, the use of recycled materials and composting to promote healthy communities and waste reduction; and,

WHEREAS, the Township of Wyckoff shall encourage, consider and use wherever practical the following methods in its' grounds maintenance policy:

1. Utilize compost landscape waste from the Township's leaf compost facility as mulch in landscaping projects.
2. The Township encourages the re-use of materials from the municipal waste stream (such as tire recycling, asphalt and milling recycling and cement) wherever possible and to decrease its' costs.
3. The Township utilizes native species and does not consider exotic plantings in its' projects primarily for cost reasons both in purchase price and for less maintenance costs and for those projects to blend into the local habitat.
4. Except for sports fields, the Township encourages minimizing lawn areas to reduce maintenance costs.
5. The Township encourages and considers landscaping projects to achieve the purposes of stormwater management. Through the use of property contours, water flow can be slowed and filtered through landscaping to improve ground water recharge and prevent erosion.
6. Significantly reduce or eliminate the use of conventional pesticides through an integrated pest management program.
7. Avoid the use of excessive fertilizers.
8. The Township refrains from watering its' lawns. Irrigation is only utilized on sports fields to maintain a healthy growth of grass for safety of the sports participants. The irrigation systems are equipped with rain sensors to achieve efficient watering schedules and water conservation. Drip irrigation systems are used and leaks promptly repaired to minimize costs.

9. The Township will continue its practice of evaluating trees and shrubs from properties where the home structure is to be demolished for the purpose of saving and transplanting the trees and shrubs onto municipal properties.

WHEREAS, the Township of Wyckoff is mindful of the various Stormwater Management Act ordinances it has adopted and the Township complies with those ordinances while simultaneously distributing such regulations to the public through its public information technology; and,

WHEREAS, the Township has further evaluated those mandated ordinances and the Township has developed 15 critical bulletins to disseminate this information to the public. They are attached as if set form by length; and,

WHEREAS, the Township of Wyckoff is mindful of the various Stormwater Management Act ordinances it has adopted and the Township complies with those ordinances while simultaneously distributing such regulations to the public through its public information technology; and,

WHEREAS, the Township has further evaluated those mandated ordinances and the Township has developed bulletins to disseminate this significant information to the public. They are attached as if set forth at length.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that the aforementioned grounds maintenance policy is hereby adopted to achieve the benefits of cost avoidance and reduction, water conservation, re-use of compost materials, recycling of materials from the municipal waste stream to promote healthy communities.

BE IT FURTHER RESOLVED, that the Municipal Clerk provide a copy of this policy to the Wyckoff Certified DPW Manager, Wyckoff Construction Code Official, Wyckoff Township Engineer, Wyckoff Recreation Director and the Wyckoff Consulting Engineer and all Department Managers.

They commonly address energy efficiency and carbon emissions reduction, water conservation, healthy and sustainably produced materials, indoor air quality, occupant productivity and health and other components of green building and sustainable development; and,

WHEREAS, the purpose of this resolution is to enhance the public welfare and to encourage that commercial, residential and civic development is consistent with the Township of Wyckoff's desire to create a more sustainable community by incorporating green building measures into the design, construction, operation and maintenance of buildings; and,

WHEREAS, the Township desires to set a leadership example in the area of green building through the implementation of energy efficiency audits and system upgrades, when required and if practical, to the municipal building stock, (e.g. improve water conservation, increase construction waste recycling and energy conservation and efficiency).

WHEREAS, the Township will distribute the attached stormwater best practices guidelines. These best practices are encouraged to help reduce loadings into stormwater systems, minimize stormwater pollution and ultimately protect waterways.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, the Township implements a Green Building Policy that will consider opportunities to incorporate green building measures into the design, construction, operation and maintenance of municipal buildings and facilities, where practical.

#1872 - AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Wyckoff in the County of Bergen find it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5 increase in the budget for said year, amounting to \$145,521.95 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Wyckoff in the County of Bergen authorized membership of this governing body affirmatively concurring that, in the CY 2019 budget year, the final appropriations of the Township of Wyckoff shall, in accordance with this ordinance and N.J.S. A. 40A:4-45, be increased by 3.5% amounting to \$145,521.95 and that the CY 2019 municipal budget for the Township of Wyckoff be approved and adopted in accordance with the ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Direction within 5 days after such adoption.

AN ORDINANCE TO AMEND CHAPTER 186, "ZONING," OF THE CODE OF THE TOWNSHIP OF WYCKOFF, ARTICLE III, "PERMITTED USES," SECTION 186-9, "USES IN THE R-15 RESIDENCE ZONE," SECTION 186-10, "PERMITTED USES IN THE B-1 CENTRAL BUSINESS ZONE," AND SECTION 186-13, "PERMITTED USES IN THE B-3 OFFICE ZONE"

BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, that the Code of the Township of Wyckoff is amended at Chapter 186, "Zoning," Article III, "Permitted Uses," Section 186-9, "Uses in the R-15 Residence Zone," Section 186-10, "Permitted Uses in the B-1 Central Business Zone," and Section 186-13, "Permitted Uses in the B-3 Office Zone."

SECTION 1 - Chapter 186, "Zoning," Article III, "Permitted Uses," Section 186-9, "Uses in the R-15 Residence Zone," shall be amended as follows:

Section 186-9. Uses in the R-15 Residence Zone.

~~Offices or studios of artists, architects, dentists, doctors, lawyers, engineers, planners, real estate and insurance brokers~~ Home occupation, subject to the following regulations:

- a. Such home occupation shall be conducted entirely within the dwelling and only by the occupants thereof and not more than one person who does not reside in said dwelling. Such use shall be clearly incidental and secondary to the use of the dwelling for dwelling purposes.
- b. The residential character of the lot and the dwelling unit shall be maintained. Neither the interior nor the exterior of the dwelling will be structurally altered so as to require compliance with nonresidential construction codes to accommodate the home occupation. No additional buildings, driveways or parking lots shall be added on the property to accommodate the home occupation.
- c. The occupation shall not produce external noise, vibration, smoke, dust, odor, heat, glare, fumes, electrical interference, runoff, waste or nuisance outside the dwelling unit. No equipment or materials associated with the home occupation shall be displayed or stored where visible from anywhere outside the premises.
- d. There shall be no direct selling of merchandise on the premises.

- e. Such use shall not occupy more than 25% of the gross floor area of the dwelling.
- f. No vehicle used in connection with the home occupation which requires a commercial driver's license to operate is allowed to be parked on the premises or on any street adjacent to the residentially zoned property.
- g. No signs shall be permitted on the exterior or interior of the home, which shall advertise or indicate the location of the home occupation office, with the exception that a professional lawyer, doctor, dentist, architect, planner or engineer shall be permitted one sign pursuant to the regulations of Section 186-26E(2).

SECTION 2 - Chapter 186, "Zoning," Article III, "Permitted Uses," Section 186-10, "Permitted Uses in the B-1 Central Business Zone," shall be amended as follows:

Section 186-10. Permitted uses in the B-1 Central Business Zone.

~~Offices or studios of artists, architects, dentists, doctors, lawyers, engineers, planners, real estate and insurance brokers and certified public accountants, when located in the building primarily used by the occupant as his dwelling and provided there are no nonresident employees and provided not more than 25% of the total floor area of the dwelling unit is used for such purposes~~Home occupation, as regulated by § 186-9

SECTION 3 - Chapter 186, "Zoning," Article III, "Permitted Uses," Section 186-13, "Permitted Uses in the B-3 Office Zone," shall be amended as follows:

Section 186-13. Permitted uses in the B-3 Office Zone.

In the B-3 Office Zone, only the following uses are permitted: professional, administrative and sales offices, provided that no storage, handling or physical transfer of goods takes place upon the premises and that any display of samples is not visible from the exterior of the structure; banking, lending and savings institutions; clubhouses for fraternal, social, charitable, recreational or veterans organizations, not conducted for profit; mortuaries and funeral homes, but not crematories; dwellings, single-family; dwellings, two-family; accessory uses incidental to a permitted use; places of worship, including parish houses and Sunday school buildings (see Article IV); incidental home occupations as regulated by § 186-9; professional artists' and photographers' studios; public buildings of a governmental nature, but not including workshops or warehouses; pay telephone booths within 10 feet of principal building; academic tutoring services, provided that not more than 1,500 square feet of floor area is devoted to these purposes.

SECTION 4 - Except as hereby amended, all other parts of Chapter 186 of the Code of the Township of Wyckoff shall remain in full force and effect.

SECTION 5 - Upon introduction, this Ordinance shall be referred to the Planning Board of the Township of Wyckoff for its review and comment.

SECTION 6 - This Ordinance shall take effect upon final passage and publication according to law.
