## ORDINANCE # 2035

AN ORDINANCE APPROPRIATING \$65,000 FOR THE ENGINEERING DESIGN AND INSPECTION WORK RELATED TO ADA-COMPLIANT IMPROVEMENTS AT CROSSWALK LOCATIONS ON COUNTY ROADS IN ANTICIPATION OF ROADWAY PAVEMENT IMPROVEMENTS UNDER A SHARED SERVICE AGREEMENT WITH BERGEN COUNTY

**WHEREAS**, the Township of Wyckoff has been advised by the Bergen County Road Department that certain County Roads will be paved by Bergen County; and

**WHEREAS**, the Township of Wyckoff is required to make ADA improvements at crosswalk locations on these County Roads ahead of roadway pavement improvements; and

**WHEREAS,** the Township of Wyckoff has entered into a Shared Service Contract with the County of Bergen, which provides for reimbursement for the engineering design and inspection work related to the construction of these ADA improvements;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, as follows:

- **SECTION 1:** The Township of Wyckoff shall proceed with the engineering design and inspection necessary for the construction of ADA-compliant improvements at crosswalk locations on designated County Roads as instructed by the Bergen County Road Department in order to facilitate the improvement of road resurfacing.
- **SECTION 2:** The cost of implementing said engineering design and inspection work shall be paid by Township funds:
  - a. \$50,000 to be authorized specifically for said purpose.
  - b. Total appropriation authorized is \$65,000.

**SECTION 3:** It is hereby determined and stated:

a. Said purpose is not a current expense. The same is an Improvement which the Township of Wyckoff may lawfully make or acquire and no part of the cost of said improvement has been or shall be specifically benefited.

- b. It is not necessary to finance this authorization by the issuance of obligations by the Township of Wyckoff pursuant to the Local Bond Law of the State of New Jersey.
- c. The total authorized appropriation in this ordinance is \$65,000.
- **SECTION 4:** The monies which the Township of Wyckoff is authorized to receive pursuant to the terms of the Shared Service Agreement between the County of Bergen and the Township of Wyckoff, shall, when received, be deposited in a Capital Fund of the Township of Wyckoff for the purpose set forth in Section 1 of this ordinance.
- **SECTION 5:** It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said purpose, since the gross debt of the Township of Wyckoff as defined under the Local Bond Law is not increased by this Ordinance, and this Ordinance authorizes no obligations in the matter of notes or bonds.
- **SECTION 6:** This ordinance shall take effect after publication thereof and final passage as required by law.
