

**ADVERTISEMENT FOR BIDS
TOWNSHIP OF WYCKOFF
BERGEN COUNTY, NEW JERSEY**

Sealed bids will be received by the Township of Wyckoff second floor Court Room in Memorial Town Hall located at 340 Franklin Avenue of Wyckoff in the County of Bergen and State of New Jersey on August 10, 2021 at 11:00 a.m. prevailing time, and then publicly opened and read aloud for:

TOWNSHIP OF WYCKOFF
BERGEN COUNTY, NEW JERSEY**

The work to be performed under this contract includes the milling and resurfacing of Mountain Avenue from Sicomac Avenue to the North Haledon border. Also include are spot 9" x 6" Hot Mix Asphalt Curb, ADA curb ramps, sidewalk, driveways, and other incidentals.

Principal items of work in the project include:

Base Bid

- 13,255 S.Y. HMA Milling, 3" or Less
- 2,205 TON Hot Mix Asphalt 9.5M64 Surface Course
- 15,470 L.F. Traffic Stripes, 4"

Alternate Bid A

- 2,745 S.Y. HMA Milling, 3" or Less
- 435 TON Hot Mix Asphalt 9.5M64 Surface Course

Alternate Bid B

- 25 L.F. Beam Guide Rail, Powder Coated
- 4 Unit Beam Guide Rail Anchorage, Powder Coated

The work contemplated under this Contract shall be completed within 60 days of the notice to proceed.

Copies of plans, specification, and contract documents will be on file for public inspection and may be obtained upon payment of \$42.00, said sum not refundable, at Boswell Engineering, 330 Phillips Avenue, South Hackensack, New Jersey 07606, between the hours of 9:00 a.m. and 4:00 p.m. prevailing time, Monday through Friday, excluding legal holidays.

Each bid must be made upon the prescribed forms, furnished with the Contract Drawings and Specifications, including the non-collusion affidavit and ownership statement compliance form and must be accompanied by a Consent of Surety and a certified check, cashier's check, or Bid Bond of not less than ten (10%) percent of the amount bid and, not to exceed \$20,000.00. Such checks and Bonds shall be made payable to the Township of Wyckoff and will be held as a Guarantee that in the event the Bid is accepted and a Contract awarded to the bidder, the Contract shall be duly executed and its performance properly secured. The successful bidder shall furnish and deliver to the Township of Wyckoff a performance and payment bond in the amount of 100 percent of the accepted bid amount as security for the faithful performance and payment of the Contract. Further, the successful bidder must furnish the policies or Certificates of Insurance required by the Contract. In default thereof, said checks and the amount represented thereby will be forfeited to the aforesaid Owner as

liquidated damages. Bids must be accompanied, in the case of corporations not chartered in New Jersey, by proper certificate that such corporation is authorized to do business in the State of New Jersey.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 regarding equal employment opportunity, as amended. All corporations and partnerships must comply with Chapter 33, of the P.L. of 1977, regarding disclosure of partners and stockholders. Each bid must be enclosed in a sealed envelope bearing the name and address of the bidder, addressed to the Owner and labeled for the MOUNTAIN AVENUE & IMPROVEMENT TO MOUNTAIN AVENUE SECTION 2.

The successful bidder will be required to comply with all provisions of prevailing wage rates as determined by the New Jersey Department of Labor.

All bids shall be irrevocable, not subject to withdrawal and shall stand available for a period of sixty (60) days.

The Township of Wyckoff reserves the right to waive any technicalities as may be deemed best for the interests of the Township of Wyckoff. The Township of Wyckoff also reserves the right not to consider any bids in accordance with the law.
