Open Public Meeting Act Statement

Deputy Municipal Clerk Shannon read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

Committeewoman Rubenstein made a motion to open the meeting for public Comment; Seconded by Committeeman Shanley. All voted in favor.

David Lucas, 420 Weymouth Drive:

Mr. Lucas requested the Township Committee assistance with a problem which was described as experienced by parents of children in the Hartung Neighborhood of Wyckoff relative to the Ramapo/ Indian Hills High School district subscription busing program. He explained that he and other parents are willing to pay for busing, however due to 100 more freshman students attending Ramapo High School all the buses are filled. The response from the school staff is not helpful, it is "this is our policy – He suggested the district accommodates the incoming students by allocation more teachers, but will not allocate more busing even when the parents are willing to pay for the busing. This evening an email from the school staff was received that explained the students from Wyckoff could take a bus to Indian Hills High School and then they would be "shuttled" to Ramapo High School that will add another hour which is not ideal.

Mr. Madigan advised he spoke to Mr. Ceurvels, the school business administrator/board secretary and he assured Mr. Madigan that a resolution was being pursued.

Mr. Shanley, advised he spoke to the district superintendent and expressed concern with the communication sent to parents. The Township Committee does

not control the school district and we are not the elected school representatives who make these decisions however we are willing to help. Mr. Lucas expressed frustration with the district reply "it is not our policy" rather than trying to find a solution.

Mr. Boonstra suggested as way of a helpful option, parents obtain the school district busing price and contract for a bus for the students directly which has occurred in the past. Mr. Lucas advised we are reaching out to the bus company also. Again, he expressed frustration with the district – Never an offer to helpalways the reply – "this is our policy" or "this is not our policy".

Joe Maurice, 416 Weymouth Drive:

Mr. Maurice suggested that the district policy of offering busing is based on a tape measure and it should be based on safety factors. He suggested it is dangerous to walk on the sidewalk over Route 208. He stated that municipalities are required to produce safe walkways to schools, school guards and traffic signals. He commented there are no sidewalks on Eder Ave.

Mr. Maurice suggested that safety should be the priority consideration and not distance. He expressed frustration that the superintendent refers parents with these issues to Mr. Ceurvels and his reply is "it is not our policy".

Mr. Maurice suggested that the NJDOE website states that municipalities can contract with the school district for busing.

Nick Ciampo, 669 Quackenbush Road:

Mr. Ciampo stated the owner of the Post Office purchased property from the adjacent church to expand the parking lot and nothing has been done. He said the property owner who leases the site to the UD Post office is named Grossman and suggested the Township Committee look into it.

Committeeman Shanley made a motion to close the public comment time of the regular business meeting; Seconded by Committeewoman Rubenstein with an affirmative vote.

AN ORDINANCE SUPPLEMENTING CHAPTER 186, "ZONING," SECTION 186-22, "REGULATIONS APPLYING TO ALL ZONES," OF THE CODE OF THE TOWNSHIP OF WYCKOFF TO PROHIBIT THE SALE OF MARIJUANA WITHIN THE TOWNSHIP

WHEREAS, the New Jersey Legislature is considering the legalization and/or decriminalization of the distribution, sale and/or consumption of marijuana within the State; and

WHEREAS, the Township Committee of the Township of Wyckoff considers the sale of marijuana within the Township to be detrimental to the public health, safety and welfare, and inimical to the current zoning of the Township; and

WHEREAS, the Township Committee desires to amend the Township of Wyckoff Land Development Code so as to provide a safe environment for all of the citizens of Wyckoff in response to the State Legislature potentially legalizing the use and sale of marijuana in the State of New Jersey; and

WHEREAS, the Township of Wyckoff has determined that the sale and distribution of marijuana presents special concerns of safety, security and general nuisances that arise as the result of the use of drugs and substances that can affect the youth of the Township and others; and

WHEREAS, given the current Comprehensive Master Plan of the Township of Wyckoff and the Development Ordinances implementing that plan there are no areas where the sale of and distribution of recreational marijuana can be safely established given the overwhelming security and safety concerns.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey as follows:

Section 1. That Chapter 186, entitled "Zoning," Section 186-22, "Regulations applying to all zones," shall be amended to add new subparagraph W., prohibiting the sale of marijuana and marijuana paraphernalia, as follows:

Section 186-22. Regulations applying to all zones.

- W. The sale of marijuana its' derivatives and paraphernalia including but not limited to equipment and/or devices associated with marijuana use is hereby prohibited in all zoning districts, except medical marijuana prescribed by a physician and dispensed by a licensed pharmacist.
- **Section 2. Repealer.** All ordinances or parts of ordinances inconsistent or in conflict with this ordinance are hereby repealed as to said inconsistencies and conflict.
- **Section 3. Severability.** If any section, part of any section or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The Township Committee of the Township of Wyckoff declares that it would have passed the ordinance and each section thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.
- **Section 4. Effective Date.** This Ordinance shall take effect immediately upon passage and publication according to law.
