The Township Committee proceeded with the Pledge of Allegiance led by Mayor Brian Scanlon

Open Public Meeting Act Statement

Deputy Municipal Clerk Shannon read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

Committeeman Shanley made a motion to open the meeting for public Comment; Seconded by Committeeman Boonstra. All voted in favor.

Louis Cicerchia, 746 Mountain Avenue. "First, I'd really like to thank you guys for your strategy and bringing Ridgewood Water to the table. Primarily I am here, I represent my family and neighbors to show support for resolution #18-264. To date I do not know anyone in this town who does not see the potential danger of the governor's politically motivated policies. It would also be curious to get minimal federal funds from FEMA via the mayor's aforementioned meeting in DC, but yet risk a multitude of things by not doing anything to combat Governor Murphy's inclination to turn our state and thus our town into an illegal immigration sanctuary. I thank you for your work and I thank you for your work on the resolution."

Chris Calabrese, 475 Berkley Drive. "I actually grew up in Wyckoff, I'm back in Wyckoff, my children go to Sicomac School. Outside the years in college and a few years after college, basically I'm back in town here. I would like to say that I appreciate all your efforts on a daily, weekly, monthly and annual basis. I know you spend a lot of time working for the town and I do appreciate that. I do want to address and state support for resolution #18-264. I think all of us started to become alerted to the issues that are surrounding sanctuary cities and sanctuary communities, things started on the docks of San Francisco to a small community in lowa with less than 5,000 people. We think these things can't happen in a community like Wyckoff and we get misguided in those thoughts. I'd like to say

thank you and again I'm in support of resolution #18-264. I do represent hundreds of other people who are not here tonight, again I express my support of resolution #18-264."

Susan Winton, 80 Logan Lane. "We have lived in this town for 52 years, our kids grew up here and I plan to spend the rest of my life living hopefully in Wyckoff. I am 100% in support of resolution #18-264. I think we ask for trouble if we make this a sanctuary town or a sanctuary state or a sanctuary country. I think this resolution reflects the feeling of most people in Wyckoff. Please keep Wyckoff as it is, don't turn it upside down. Thank you."

Mike Homaychak, 553 Helena Avenue: "I'm here to tell you about some pot holes I have on my street and I send an email in on the website and they were taken care of. I'm no longer hitting that pot hole every day, the guys did a great job filling the pot holes. Thank you. I don't know if the email helped, but somebody did it. "

Mayor Scanlan: "I'm sure the email helped."

"On the Ridgewood Water subject, I just feel that we need to Mr. Homeychak: do something there. We have a court case that says they owed us a rebate. It said they were using the monies to keep their taxes lower in Ridgewood and deferring money from our water utility towards the Ridgewood municipal budget. We won that case and what happened? They hired a consultant who says the rate was good there was nothing wrong with it, what about the water restrictions? Meanwhile, it rains like every other day practically this year. Every reservoir is overflowing in the state. They can't buy the water from somebody else if they don't have the well capacity? We have a moratorium, we can't hook new houses up and we have to drill wells, this is crazy. They have to deal with this, this is not right what they are doing to us here. You know, its nuts and yet what Tim wants to do, yes let's put some pressure on them. We need to get back into a position where it's a utility not serving the people of Ridgewood only, but the people from all four (4) towns. That needs to be done. Put pressure on them, it's not right, the newspaper made them sound like they are doing us a favor, they are spending a million dollars in infrastructure, and it's federally required that they have to do those upgrades. They would have never done it, they don't spend any money on Ridgewood Water unless they have to, except maybe for Ridgewood, but the rest of us we are second class citizens. I just want to say on the sanctuary city and sanctuary state my feeling is we should support legal immigrants, people that are here illegally – no. We shouldn't spend our money on them, they shouldn't be here illegally, there's a legal way of coming into this country the way our forefathers did so why should they come in that way too? I'm for the resolution as it's stated. Thank you."

Mayor Scanlan: "Bob, Mr. Homaychak's comments made me think of something, when we go as the governing body to Ridgewood when they have their meetings about Ridgewood Water Utility I think it might be good if we included in our town wide email blast information for residents about when the next meeting is scheduled, when they are going to be discussing the water utility. This way they can hear what's going on other than from us. I encourage you guys if you haven't signed up for enews if you haven't please do. The town enews I mean. We can include that in there and if you guys would go and give them the same feedback that you have been giving us tonight about Ridgewood Water. I think it would be helpful, because then they would be hearing not just from people on governing bodies across the three (3) towns, but also from the average rate payer."

Tim Buchman, 430 Meer Avenue. "Last time I spoke I mentioned one immigrant ethnicity, then I quoted the old want ad 'No Irish Need Apply'. I'm going to mention a different ethnicity tonight and it's a closer to Wyckoff story. When I

first moved to Wyckoff, back in colonial times. I use to get my hair cut by an elderly gentlemen on Franklin Avenue named Frank the barber. He was a character. He was alone, he had one chair and I chatted with him like you do your barber. He told me about running through the woods next to Rt. 208, being newer to town then and one day I asked him, Frank, would you say this is a Dutch town back then? He said, the Dutch boys call me a Diego. Just to make a slight addition to the previous speaker and I know this mainly through the Arthur Miller play View from the Bridge, but some Italian immigrants called themselves submarines, because they jumped off ships in New York harbor and swam ashore. It's important to remember that many upstanding citizens in the United States today are the decedents of illegal immigrants. I am not going to criticize anyone for bringing the national issue of immigration into a local political contest because I think it's a legitimate strategic decision. I want to criticize something I heard at the last meeting, I can't check the minutes because they haven't been approved yet. I believe I heard it said on the dais at the previous meeting of this month (September 4th) that Governor Murphy's election included the participation of votes by illegal immigrants. The reason that bothers me is that I consider voting more sacred than many other activities. There is not a shred of evidence that Governor Murphy was elected with illegal immigrant votes."

Mr. Shanley: "Mr. Buchman, I will respond to that because I miss-spoke. I was concerned that the next election for Mr. Murphy was going to be based on illegal votes. I did miss-speak, I spoke to the Mayor, I miss-spoke from the dais. My concern is this, will the next election make New Jersey a sanctuary state to register illegal immigrants? They are getting county ID's, they are getting state ID's and no one is checking to make sure they are actual citizens, which is required in order to vote in this country."

Mr. Buchman: "Thank you for that correction and I will drop that topic."

Mr. Shanley: "Sorry I miss-spoke."

Mr. Buchman: "I will say my conclusion to that discussion was going to be, and not referring to anyone in this room, it is a national policy of the Republican Party to take any measures possible to suppress voter turnout by whatever legal means can be done."

Mr. Boonstra: "I have to object to that. I've been a Republican my whole life and I speak for myself and anyone else in this state, that is not a policy. It never was and it never has been. Quite honestly, Tim, I'm a little offended by that."

Mr. Shanley: "The more people that vote the better."

Mr. Buchman: "Well, there was a quote in yesterday's New York Times, a member of a Republican think tank who stated exactly that the best possible thing they could do would be suppress voter turn out. The columnist continued with a list of occasions when poor and vulnerable people have been struck from voting roles in the hope they wouldn't succeed in voting. I deny offending anyone in this room, but I stand by my statement about the national Republic policy. Thank you."

Mr. Madigan: "Well they nearly succeeded up in Boston because you can't believe all the people who voted early and often."

Mr. Kalpagian, 488 Fairfield Road. "Good evening. I spoke a couple of weeks ago on this issue and I want to reiterate to the entire board that you guys are doing a really good job as a group. Thanks for putting in your time, you are here every other week going to your committee meetings and attending events, I don't think people realize how much time you put in and I appreciate it. My youngest is in elementary school, I thank you for having the police presence there for the first

few days of school. I think that was great. I also appreciate the work that you are doing to straighten out Ridgewood Water, I don't think there's a resident in town who is happy with Ridgewood Water. Anything you can do including applying pressure is appreciated. I too, much like Mr. Buchman, would like to reiterate some things that I had pointed out. I don't like when the national political agenda becomes part of what's going on. You were voted in, you are a township committee and are here to do the best for the Township of Wyckoff. Since we are putting public comments on the record I would like to state for the record that I think all the political non-sense, the badgering back and forth, the labeling of white supremacy and political agendas, and when I look at this resolution this is common sense to me. I want to bring a nonpolitical view to it, I'm a resident of the town I live here and I raised my kids here because of the services, the schools and we feel relatively safe. We think we are. Criminals are not stupid people whether they are here legally or illegally, like I said I'm second generation born here. We came over legally through the ports and committed no crimes and we had no problems. It's a simple formula, the criminal element is intelligent if there are people here illegally and they commit a crime or their intent is to commit a crime much like MS-13 and they are up as far as Paramus and Ramsey. They are close to us. If there is an illegal immigrant who wants to commit a crime, where will they deal the drugs, where will they commit those crimes? Somewhere where the local police will not report them to the FBI? If that were my intent that's where I would go. They are just as smart as I am I'm sure. The other thing I'd like to point out is that the resolution – this got carried away. If an immigrant or somebody rear-ends somebody with their car and gets a traffic ticket their property is not going to get ceased, you are not going to bust into the house. This is simply if somebody is here illegally, and they commit a crime, that you will notify the federal government. Again, this is common sense. I'm for the committee to do the right thing and use common sense and leave politics and agendas out of the picture. Thank you."

Mayor Scanlan: "I'd like to add to what you said because we don't have a definition of what it means to be a sanctuary state and nothing has been done by the governor on that front. I would be shocked if it would give illegal immigrants cart blanche to commit any crime and not suffer any consequences. I think the attorney general's directive, which was a good point to discuss at length at our last meeting, makes it clear that anyone here, whether legal or illegal, who have committed a crime will be prosecuted for it. I think it would be ridiculous if that were somehow related with sanctuary state. We will see what the governor decides. "

Mr. Kalpagian: "The only concern in the other direction is because that language is unclear, how they are prosecuted, who is to be notified, I think it's important to get out there ahead as the local authority so that people realize that if you are here illegally and you do something wrong beyond the parking ticket or rear ending another car in traffic, it is important that they know that the federal authorities will be notified. It's a common sense approach and I thank Mr. Shanley. Thank you for taking the time I think you did a good job. Thank you all of you. Thank you."

Mrs. Winton: "I would like to comment on his comments about people being illegal immigrants. If you read the newspaper there's a case of a 16 year old girl in New Jersey who was killed by an illegl immigrant."

Mr. Boonstra: "Come up to the microphone please, this isn't a discussion, these are comments to the township committee on the topic of the resolution that we are proposing for tonight. You can speak to Mr. Kalpagian later."

Mayor Scanlan: "Thank you."

WHEREAS, the Township Committee has determined that there is a need for personnel policies and procedures to ensure that employees and prospective employees are treated in a manner consistent with these laws and regulations.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that the Policies and Procedures Manual attached hereto is hereby adopted.

BE IT FURTHER RESOLVED, that these personnel policies and procedures shall apply to all Township of Wyckoff officials, appointees, volunteers and independent contractors. #18-262 Requesting Restoration of the Full State and Local Tax (SALT) Deduction and Opposing Legislation Which Makes the Cap Permanent

Whereas, Congress in the Tax Cuts and Jobs Act of 2017 limited the State and Local Tax (SALT) deduction to a maximum of \$10,000 through 2025 and is giving serious consideration to permanently limiting the federal income tax deduction for state and local taxes in legislation this fall; and

Whereas, this deduction, which has been in place for more than 100 years, was heavily utilized by taxpayers of the Township of Wyckoff and other taxpayers of New Jersey, and

Whereas, the state and local tax deduction is a fundamental principle of federalism and without it our residents are faced with double taxation as they are forced to pay federal income taxes on the taxes they pay to state and local governments, in other words, "a tax on a tax"; and

Whereas, the New Jersey Association of Counties (NJAC) and other governmental organizations in impacted states also strongly oppose the limitation of the (SALT) deduction; and

Whereas, the \$10,000 SALT deduction cap fails to take into account the higher cost of living in New Jersey, the 300-year-old structure of our county and municipal governments, and its negative economic effects; and

Whereas, the IRS is changing the rules regarding charitable deductions which were available to address the SALT deduction cap and is rendering the use of a charitable deduction to mitigate the SALT deduction cap impossible; and

Whereas, the IRS has reported that in 2016 218,290 federal income returns from Bergen County used the SALT deduction and that the average SALT amount claimed was \$24,783, \$14,783 higher than the current \$10,000 cap, and

Whereas, the SALT deduction cap results in a significant net tax increase for New Jersey residents and especially for residents of Wyckoff; and

Whereas, the SALT deduction cap is also negatively impacting the real estate market in our area; and

Whereas, a study by the nonpartisan Institute on Taxation and Economic Policy (ITEP) states that New Jersey taxpayers make up just 2.8% of personal federal taxpayers but paid 4.5% of personal federal income taxes before the SALT deduction cap and will pay 4.7% of personal federal taxes with the SALT deduction cap; and

Whereas, a study by the nonpartisan Rockefeller Institute of Government determined that even before the passage of the Tax Cuts and Jobs Act that because of the high level of federal

taxes New Jersey residents pay the state gets back only 74 cents for each federal tax dollar it sends to the federal government and ranks dead last among the 50 states on return of federal dollars; and

Mr. Madigan: "One comment before voting regarding resolution #18-262 requesting full restoration of state and local tax reductions. I am voting yes under the presumption of correctness that the numbers in here, which I was assured were correct, are correct. I think it's good and I vote yes."

Mayor Scanlan: "I would like to comment regarding the resolution on state and local tax deduction and the federal limitation, which was passed at the end of 2017 and I wanted to note for the record that 14 of the 15 states most negatively impacted by the SALT reduction cap are those whose majorities did not vote for President Donald Trump in the 2016 Presidential Election.

The other comments I would like to make are in reference to the resolution on sanctuary state, things that I hoped would have been in the resolution, but in the interest in trying to arrive at a consensus we agreed to leave them out and I wanted to note these for the record. I wanted to note that the rate of crime committed by illegal immigrants in this country is about 1/3 the rate of native citizens. I also wanted to note that state and local taxes paid by undocumented immigrants just in New Jersey are estimated to be \$587,000,000.00 annually. I also want to note that of that \$587,000,000.00, \$59,000,000.000 taxes are paid by Dreamers. Finally, there is a reference to the \$4,400,000.00 a year which is allocated to tuition aid grants for those same Dreamers, this represents a little more than 1% of the total amount which New Jersey budgets \$426,000,000.00 per year on financial aid. I just wanted to point those out, those were in one of the drafts that was passed back and forth which were eliminated in the final draft. I vote yes."
