#16-180 Authorize Award of Contract from National Cooperative Contract – Fire Apparatus

WHEREAS, the Township Committee adopted resolution #15-196 on July 21, 2015; and,

WHEREAS, the Township of Wyckoff is a member of the Houston-Galveston Area Council (HGAC) purchasing program, a national purchasing cooperative; and,

WHEREAS, HGAC published notices soliciting sealed competitive bids on in the November 1, 2015 issue of the Houston Chronicle, and the November 8, 2015 issue of the Houston Chronicle; and,

WHEREAS, on November 17, 2015 at 2:00pm competitive sealed bids were publicly opened and then their contents read aloud for the purchase of fire apparatus; and,

WHEREAS, the HGAC on January 19, 2016 awarded multiple contracts for the purchase of fire apparatus via contract #FS12-15A for the period February 1, 2016 thru November 30, 2017; and,

WHEREAS, P.L. 2011 c139 (the “Law” or “Chapter 139”) allows local contracting units to utilize national cooperative contracts as a method of procurement; and,

WHEREAS, the New Jersey Department of Community Affairs, Division of Local Government Services (DLGS) has published LFN 2012-10, a Local Finance Notice detailing guidance to contracting units desiring to purchase under the Law; and,

WHEREAS, the Township Administrator, Fire Chief and Public Works Manager are satisfied that the procurement conducted by HGAC and the contract awarded to Pierce Manufacturing, Inc. with the associated documentation submitted by both HGAC and Pierce Manufacturing, Inc. are compliant with the guidance in LFN 2012-10; and,

WHEREAS, the Township of Wyckoff published a notice of intent to award contract in the May 6, 2016 edition of the Ridgewood News, (the Township’s designated official newspaper for legal notices) and posted the notice on its website Wyckoff-nj.com at the bids and jobs quick link and its bulletin board in Town Hall where notices are customarily posted; and,

WHEREAS, a total purchase price for the fire apparatus is \$588,328.73; and,

WHEREAS, a cost savings determination in accordance with LFN-2012-10 has been performed resulting in a cost savings based on price and consideration of other factors as compared to other apparatus prices from the HGAC National Cooperative Contract and compared to, State contract pricing and the cost of a career firefighting department; and,

WHEREAS, the Chief Financial Officer has issued a certificate of available funds indication that sufficient funds exist in capital ordinance #1800 for this purchase; and,

WHEREAS, Sicomac Fire Company #3 has donated \$20,700 towards the purchase of a Pierce Fire Pumper in accordance with N.J.S.A. 40A:11-13.1 & N.J.S.A. 40A:5-29; and,

WHEREAS, the Township Attorney has reviewed this procurement and concurs with the procurement action through this national cooperative contract.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey as follows:

1. The Township of Wyckoff is authorized to purchase from the HGAC National Cooperative Contract.
2. After a careful and thorough consideration of cost and other factors, the proposal submitted by Pierce Manufacturing, Inc. in accordance with HGAC Contract #FS12-15A in amount of \$528,328.73 is hereby accepted.
3. The Township Administrator is the hereby authorized to issue a purchase order to Pierce Manufacturing, Inc., 2600 American Drive, Appleton, Wisconsin 54914 in the amount of \$588,328.73 consisting of the base apparatus and unit price options provided (or published) in the HGAC bid specification totaling \$538,472.00 and apparatus unit items not provided for in the bid specification totaling \$57,356.73 or 10.65% authorized by resolution #2016-181.
4. This contract, consistent with the HGAC contract and NJSA 40A:11-36(7) includes a trade-in for the existing 1983 Pierce Fire Pumper at the time of delivery of the 2017pumper.
5. This procurement is consistent with N.J.S.A. 40A:11-13.1 & N.J.S.A. 40A:5-29.

#16-181 Authorize Change Order #1 Fire Apparatus

WHEREAS, the Township Committee of the Township of Wyckoff has awarded a contract to Pierce Manufacturing, Inc., for the purchase of a Fire Pumper Apparatus that reflects the operational needs of the Wyckoff Volunteer Fire Department and satisfies the desires of the volunteer firefighters at Sicomac Volunteer Fire Company #3 through a National Cooperative Pricing System contract based on price and other factors via Resolution #16-180, dated June 21, 2016 for \$538,472.00; and,

 - (iii) The display of merchandise in connection with special sales, up to six (6) consecutive days and no more than five (5) times per year, within the hours of 7:00 a.m. and 6:00 p.m., upon the submission and approval of a written application to the Township Committee.
 - (iv) The display of outdoor decorative items for sale, located in the rear yard and outside of any parking areas.

These surfaces shall include but not be limited to building coverage, driveways (paved, ~~or gravel, cinder or pavers~~), paved areas, ~~patios, walkways~~, tennis courts, ~~pavers, water surface areas of swimming pools~~ and decks which do not allow free drainage of rainwater through to the ground underneath. Impervious coverage shall not include retaining walls, the surface areas of swimming pools, and/or walkways and patios that are constructed of gravel, cinder, pavers, blue stone or other materials that allow for the free drainage of rainwater through to the ground underneath.

WHEREAS, the Township Committee of the Township of Wyckoff previously adopted Ordinance Section 186-22 U which prohibits the operation of businesses or commercial establishments between the hours of 1:00 a.m. and 5:00 a.m.; and

WHEREAS, the Township of Wyckoff adopted Section 186-22 U with the purpose of preserving Wyckoff’s small town charm and character; and

WHEREAS, the Township Committee adopted Section 186-22 U with the purpose of maintaining and preserving the peace, privacy, and repose of the residents of Wyckoff; and

WHEREAS, business owners and residents within the Township of Wyckoff have requested an expansion of the hours of operation for restaurants with plenary retail consumption licenses to 2:00 a.m.; and

WHEREAS, the Township Committee has decided to expand the hours of operation of restaurants with plenary retail consumption licenses on a limited basis for Fridays, Saturdays, and New Year’s Eve only; and

WHEREAS, the Township Committee expands the hours of restaurants with plenary retail consumption licenses on a limited basis as stated above with the understanding that such hours of operation will revert to the current restrictions if, in fact, it is later determined that the expanded hours of operation pursuant to this ordinance have a negative impact upon the peace, privacy, health, safety, and welfare of the residents of the Township of Wyckoff or a negative effect upon the health, safety, and welfare of the law enforcement officers, emergency response volunteers, and/or business owners of the Township of Wyckoff.

No other products, goods or services may be sold by the commercial establishment during such hours. **AN ORDINANCE OF THE TOWNSHIP OF WYCKOFF BANNING THE SALE OF DOGS

WHEREAS, a significant number of puppies and kittens sold at pet shops come from large-scale, commercial breeding facilities where the health and welfare of the animals are not adequately provided for (“puppy mills” and kitten mills,” respectively). According to The Humane Society of the United States, it is estimated that 10,000 puppy mills produce more than 2,400,000 puppies a year in the United States and that most pet shop animals originate from these puppy and kitten mills; and

WHEREAS, the documented abuses endemic to puppy and kitten mills include over-breeding; inbreeding; minimal to non-existent veterinary care; lack of adequate and nutritious food, water and shelter; lack of socialization; and lack of adequate exercise; and

WHEREAS, the inhumane conditions in puppy and kitten mill facilities lead to health and behavioral issues in the animals bred in those facilities, which many consumers are unaware of when purchasing animals from pet shops due to both a lack of education on the issue and misleading tactics of pet shops in some cases. These health and behavior issues, which may not present themselves until sometime after purchase of animals, can impose exorbitant financial and emotional costs on consumers; and

WHEREAS, current Federal and State regulations do not adequately address the sale of puppy and kitten mill dogs and cats in pet shops; and

WHEREAS, restricting the retail sale of dogs and cats to only those that are sourced from shelters or rescue organizations is likely to decrease the demand for puppies and kittens bred by mills, and is likely to increase demand for pets from animal shelters and rescue organization; and

WHEREAS, according to the New Jersey Department of Health 2014 Animal Intake and Disposition Survey, due in large part to pet overpopulation, more than 20,000 dogs and cats are euthanized in New Jersey animal shelters annually. Restricting the retail sale of dogs and cats to only those that are sourced from animal shelters and rescue organizations will likely reduce pet overpopulation and thus the burden on such agencies and financial costs on local taxpayers; and

WHEREAS, across the country, thousands of independent pet shops as well as large chains operate profitably with a business model focused on the sale of pet services and supplies and not on the sale of dogs and cats. Many of these shops collaborate with local animal shelters and rescue organization to offer space and support for showcasing adoptable homeless pets on their premises; and

WHEREAS, this Ordinance will not affect a consumer's ability to obtain a dog or cat of his or her choice directly from a breed-specific rescue organization or a shelter, or from a hobby breeder where the consumer can see directly the conditions in which the dogs or cats are bred, or can confer directly with the hobby breeder concerning these conditions; and

WHEREAS, the Township Committee of the Township of Wyckoff believes it is in the best interests of the Township of Wyckoff to adopt reasonable regulations to reduce costs to the Township of Wyckoff and its residents, protect the citizens of the Township of Wyckoff who may purchase dogs or cats from a pet shop or other business establishment, help prevent inhumane breeding conditions, promote community awareness of animal welfare, and foster a more humane environment in the Township of Wyckoff.

SECTION 1. Chapter 111-19 Sale of Dogs and Cats

A. Definitions.

- (i) **Animal care facility-** an animal control center or animal shelter, maintained by or under contract with any state, country, or municipality, whose mission and practice is, in whole, or significant part, the rescue and placement of animals in permanent homes or rescue organizations
- (ii) **Animal rescue organization-** any not-for-profit organization which has tax-exempt status under Section 501(c)(3) of the United State Internal Revenue Code, whose mission and practice is, in whole, or significant part, the rescue and placement of animal in permanent homes.
- (iii) **Cat-** a member of the species of domestic cat, *Felis catus*
- (iv) **Dog-** a member of the species of domestic dog, *Canis familiaris*
- (v) **Offer for sale-** to sell, offer for sale or adoption, advertise for the sale of, barter, auction, give away or otherwise dispose of a

dog or cat.

- (vi) **Pet shop**- a retail establishment where dogs and cats are sold, exchanged, bartered or offered for sale as pet animals to the general public at retail. Such definition shall not include an animal care facility or animal rescue organization, as defined herein.

B. Restrictions on the Sale of Animals.

- (i) A pet shop may offer for sale only those dogs and cats that the pet shop has obtained from or displays in cooperation with:
- a. An animal care facility; or
 - b. An animal rescue organization.
- (ii) A pet shop shall not offer for sale a dog or cat that is younger than eight weeks old.

C. Severability.

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason, such decision shall not affect the remaining portions of this Ordinance which shall continue in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be severable.

SECTION 2.

All other sections of Chapter 111 shall remain in full force and effect except as modified herein.

SECTION 3.

This Ordinance shall take effect upon final passage and publication as required by the law.
