Meeting Called To Order

Mayor Kevin J. Rooney called the regular meeting of the Wyckoff Township Committee in the Municipal Court Room to order at 8:00 pm.

Flag Salute

The Township Committee proceeded with the Pledge of Allegiance led by Mayor Kevin J. Rooney.

Invocation

The Invocation was given by Reverend Scott Bostwick from Grace United Methodist Church.

Attendance

Township Committee Present: Mayor Kevin J. Rooney; Committee Present: Rudolf E. Boonstra, John A Carolan, Thomas J. Madigan and Brian D. Scanlan **Staff Present:** Township Administrator Robert J. Shannon, Joyce C. Santimauro, Municipal Clerk and Township Attorney Robert Landel.

Open Public Meeting Act Statement

Municipal Clerk Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filled with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

Mayor Kevin Rooney said this is the time and place for the public comment for anything on or off the agenda five minutes per speaker.

Francis Nusspickle, 463 George Place- Mr. Nusspickle indicated that he is the past president of Activities Unlimited which he described as a non-profit organization which provides activities for retired senior men that is sponsored by the Wyckoff Reformed Church. The average age of its' member is 75 years of age. Mr. Nusspickle indicated that his organization consists of approximately 250 active members of which 136 are residents of Wyckoff and 114 are nonresidents. Activities Unlimited provides twenty different activities for their members. Activities Unlimited meets every Wednesday at the Larkin House from 9:00am to 3:30pm and they also meet the first Friday morning of every month at the Larkin House from 9:00am to noon. Mr. Nusspickle also stated that a number of their members provide services within the town; for example Activities Unlimited has an eight piece band which periodically plays for the residents of the Christian Health Care Center and a number of their members volunteer their time as tax preparers and some members perform maintenance at the Rose Garden. Mr. Nusspickle requested a discounted rate for the use of the Larkin House. The current rate is \$1,000,00 but the proposed decision of the governing body will increase the rate to \$2,000.00 which would be discounted from \$3,900.00. Mayor Rooney asked if Activities Unlimited Membership pays annual dues and Mr. Nusspickle indicated that members do pay dues of \$50.00 per year. Activities Unlimited also has a number of inactive residents who continue to pay the \$50.00 yearly dues. The Township Committee and Mr. Nusspickle engaged in a discussion regarding the use and recreational value of

utilization of the Larkin House for Activities Unlimited and the Townships efforts to keep up with the costs of maintaining the Larkin House that includes expenses such as maintenance, cleaning, snow plowing, opening and closing of the building and stocking the facility with paper products. Similar charges in facilities for area towns were evaluated and the Library all, which greatly exceeded the proposed increase.

The Township Committee discussed the process of the ordinance which proposes a \$75.00 per use fee. However, the ordinance allows the governing body through a policy decision which will be reflected in the meeting minutes to provide a discount. The Township Committee has always provided a discount to Activities Unlimited and the Coast Guard Auxiliary which uses the facility fifty two times a year. It was indicated that the Activities Unlimited last year utilized the Larkin House for sixty four uses for \$1,000.00 and the Coast Guard Auxiliary used it sixty one times for \$1,000.00. Various compromised proposals were suggested by the governing body members which included \$2,000.00 for sixty four uses and permit the fee to remain unchanged for the next three years as well as a compromised fee for \$38.00 per use for the Coast Guard Auxiliary and Activities Unlimited for the balance of 2016. A discussion then resulted. The Township Committee annually looks at fees, specifically increasing recreation user fees, building permit fees and other user fees. The municipal budget is subject to increases beyond our control for things such as the cost of street lighting and other utility costs.

Bob Martone, 62 Wanaque Road, Hewitt, NJ – Mr. Martone is an officer with the Coast Guard Auxiliary and explained that their members pay dues of \$60.00 per year of which the lion share of that amount is sent to the Coast Guard in Washington DC that provides insurance for their activities. The Coast Guard Auxiliary requests that the fee remain the same at \$1,000.00 for their yearly use. Mr. Martone also stated that the Coast Guard Auxiliary is also prohibited from conducting fundraiser activities. A question was asked in regard to how many boating classes have been provided in the past three years. The original discussion with Coast Guard Auxiliary at the discounted rate of \$1,000.00 would also include the Coast Guard conducting boat safety courses at the Larkin House with a discounted rate specifically for Wyckoff residents. It was stated that two boating classes were conducted.

Susan Winton, 80 Logan Lane – Mrs. Winton expressed her opposition to the rent increase. She indicated that she is a member of the West Bergen Tea Party and they rent the Larkin House periodically and provide speakers as part as creating an informed electorate. The West Bergen Tea Party does not have a membership; the folks who attend are ask to provide a financial contribution for the use of the Larkin House. Mrs. Winton indicated that she receives very little for her tax payment, she performs her own leaf collection although she does receive snow plowing. Mrs. Winton urged the governing body to reconsider the rent increase.

Ken Porro, 15 Pace Drive, - Mr. Porro introduced himself as the Wyckoff Elected Representative to the Ramapo Indian Hills High School Board of Education. He also serves as the liaison to the municipality. Mr. Porro reported that frequently Mr. Madigan and Mr. Boonstra attend their meetings as liaisons. Mr. Porro provided the governing body with the following update. The Board of Education met on March 14, 2016. They routinely meet on the second and fourth Monday of the month and the Board of Education decided to give back three of the four extra snow days that were not utilized. One give back day will be May 31st and the other two days will be the Fridays after the Ramapo and Indian Hill proms. Additionally the school board members introduced their budget for 2016 and it is under the two percent cap. In the past years they performed a number of unglamorous requirements but important requirements such as roof repairs and window replacements were accomplished. They are currently grappling with

challenges at Indian Hills High School concerning off street parking. They are encouraging carpooling and considering providing students who carpool with parking permits for the limited parking spaces that are available. The Board of Education plans on continuing to allow students when they enter high school to choose either Ramapo or Indian Hills and to continue the academic parity of similar classes taught at both high schools. Committeeman Brian Scanlan indicated that a parent had told him that there were fifty empty parking spaces in the teachers' parking lot and asked if the open parking spaces could be utilized. Mr. Porro said that the labor contract between the teachers and the Board of Education provides for a separate parking lot for the teacher vehicles separate from the student vehicles. Committeeman Madigan indicated that he has heard that same comment and his understanding is that it is not fifty parking spaces that are available; it is that some teachers need to spend part of their day at one high school and then go to the other high school. It may look like spots are open, but they are needed for the teachers who teach at both high schools. Mr. Porro advised that the Board of Education is looking into parking school buses differently to free up more student parking.

Marge Korteweg, 411 Sicomac Avenue – Mrs. Korteweg indicated she is a member of the Coast Guard Auxiliary and that the Auxiliary is planning a navigation course that will be available for the public soon.

Susan Winton, 80 Logan Lane – Mrs. Winton inquired when does the rate increase for the Larkin House take effect. The Township Committee indicated the rate increase will take effect April 15, 2016.

Jim Mallen, 342 Calvin Court- Mr. Mallon introduced himself as a member of Activities Unlimited, an election worker and a retired school business administrator. Mr. Mallen complimented the governing body on their thorough review of the request regarding extending the hours for liquor licenses establishments and indicated that the Activities Unlimited would sincerely appreciate receiving a discounted rate for the use of the Larkin House since it is a great opportunity for retired men to socialize.

The Township Committee voted unanimously to close the public portion of the meeting.

Mayor Rooney advised that the consent agenda consists of the introduction of the 2016 Municipal Budget. It will have a public hearing and consideration for adoption on April 19, 2016.

Mayor Rooney advised that the Finance Committee consisting of himself, Deputy Finance Committee member John Carolan, CFO Diana McLeod and Administrator Robert J. Shannon reviewed each line item over approximately 20 meetings. The theme of this budget is "austerity". Not all budgetary requests were approved to achieve the purpose of limiting the budget. The new user friendly budget is posted online and shows the municipal purpose tax. A tax increase was limited to of 1.43% or \$31.12 on an average residential home assessment of \$778,100.00. The tax levy for schools and the county which are not under the control of the Township Committee are not formally available.

The budget is within the 2% tax levy cap for expenditures that are subject to the cap. The budget appropriations subject to the cap are within the 3.5% cap. The municipal purpose tax increase will increase 4/10th of 1¢ from 24.1¢ per \$100.00 of assessed valuation to 24.5¢ of \$100.00 of assessed valuation. The average home (assessed at \$778,100.00) will pay \$31.12 more in 2016 from \$1,875.72 in 2015 \$1,906.35 in 2016.

The Administrator recognized the Finance Committee and the Township Committee for their good work and the efforts of CFO, Diana McLeod.

#1797 – AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

ORDINANCE #1797

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Wyckoff in the County of Bergen find it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$480,061.00 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Wyckoff in the County of Bergen authorized membership of this governing body affirmatively concurring that, in the CY 2016 budget year, the final appropriations of the Township of Wyckoff shall, in accordance with this ordinance and N.J.S. A. 40A:4-45, be increased by 3.5% amounting to \$480,061.00 and that the CY 2016 municipal budget for the Township of Wyckoff be approved and adopted in accordance with the ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Direction within 5 days after such adoption.

SECTION 1. Chapter 157, Sewers, Part 2, Article XI, Section 157-62, Schedule of Charges, is hereby replaced with the following:

- A. The sewer service charge hereby established for 2016 shall be sufficient to:
- (1) cover all the charges, costs and expenses related to the sewer service, such as, but not limited to, the charges of the Northwest Bergen County Utility Authority, the charges of the Boroughs of Midland Park and Waldwick, pump stations and ejector station operation and maintenance costs, and all the costs incurred by the Township of Wyckoff in collecting its sewer service charges; and,
 - (2) create a reasonable reserve for maintenance and repairs.
- B. The sewer service charge shall be an annual charge commencing upon the date upon which a building connection is approved by the Township, and such charge shall be on the following basis and this rate shall stay in effect until subsequently modified by ordinance amendment:
