Mayor Kevin J. Rooney called the regular meeting of the Wyckoff Township Committee in the Municipal Court Room to order at 8:00 pm.

Open Public Meeting Act Statement

Municipal Clerk Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

No one came forward to speak.

The Township Committee voted unanimously to close the public portion of the meeting.

Public Hearing: To receive comments and suggestions for the Township's 2015 Bergen County Open Space Park Improvement & Development Grant Application. The Township Committee is considering resurfacing the existing basketball courts and replacing the backboard and rim systems at Memorial Field.

Mayor Rooney indicated that the Township Committee of the Township of Wyckoff shall next conduct a public hearing. The purpose is to receive comments and suggestions for the Townships 2015 Bergen County Open Space Park Improvement and Development Grant Application. The Township Committee is considering resurfacing the existing basketball courts and replacing the backboard and rim systems in Memorial Field Complex. Mayor Rooney stated before we have public comment Mr. Robert Shannon the Administrator of the Township of Wyckoff will provide additional information.

Mr. Robert Shannon, Administrator, stated that Bergen County provides a grant opportunity every year for municipalities in Bergen County to improve their parks and recreational facilities. The funds are appropriated from taxes paid by taxpayers to Bergen County under the Bergen County Open Space Tax. Bergen County assigns an allotment of funds to each of its regions in Bergen County. The Township of Wyckoff is one of thirteen (13) municipalities in the Northwest Bergen Region and the Township has participated in this program since the beginning and has been able to accomplish meaningful and useful recreational improvements for the enjoyment of the residents of Wyckoff and the public who visit our recreational facilities.

In 2015 the Parks and Recreation Advisory Board has suggested that the focus of this year's grant be applied to resurfacing the basketball courts in Memorial Field. The Township of Wyckoff has six (6) basketball courts in Memorial Field located between the roller hockey rink and the tennis courts which were improved approximately fourteen years ago. The purpose of this grant is to maintain the existing footprint of the basketball court; mill out the cracks in the basketball court surface, resurface the court, and replace the six (6) poles, backboards and rims. The backboard systems are all leaning and have reached there useful life. The reason this grant application is proposed is because the basketball court surfaces have significant cracks in them. The Public Works Department has attempted over the past three to four years to patch repair these cracks. It is clear that the basketball courts need to be resurfaced. Therefore the Parks and Recreation Advisory Committee and the staff have recommended a \$20,225.00 grant application to perform this repair.

Mayor Rooney asked for public comments.

Tim Buchman – 430 Meer Avenue – Mr. Buchman asked if the basketball rims and backboards are constructed at a lower height for women basketball players. The reply was no - the ten foot standard is consistent for both men and women basketball play.

Jim Savage – 448 D Bromley Place – Mr. Savage asked if this grant application included a matching appropriation. Mayor Rooney replied all Bergen County Park Development Grants require a 100% match. Therefore the Township of Wyckoff if successful will appropriate in the 2016 budget a similar amount for this project. Essentially the total cost has been reduced to \$40,500.00.

With no further public comments Mayor Rooney indicated the agenda for this evenings meeting includes a resolution which the Township Committee will consider to authorize this grant application for the resurfacing of the basketball courts.

WHEREAS, an application for 2014-2015 renewal of the inactive plenary retail consumption liquor license of the Brownstone Inn, Inc., dba The Brownstone, 625 Wyckoff Avenue, Wyckoff, New Jersey was received on June 9, 2014; and,

WHEREAS, the 2014-2015 inactive plenary retail consumption liquor license of The Brownstone was not renewed by the Township of Wyckoff due to The Brownstone's owner Mr. Aziz Kastrati's conviction of a federal crime and time served in prison and the necessary transfer of the liquor license from Mr. Aziz Kastrati that had not taken place; and,

WHEREAS, both state and municipal fees associated with the 2014-2015 renewal of the inactive plenary retail consumption liquor license of The Brownstone were paid in full and the tax clearance certificate was issued by the State of New Jersey; and,

WHEREAS, on March 18, 2015 an ABC change of corporate structure application was submitted to the Township Clerk that transferred 100% of the Brownstone Inn Incorporated stock from Mr. Aziz Kastrati to his wife Mrs. Hafi Kastrati; and,

WHEREAS, after receipt of The Brownstone's change of corporate structure application, the required newspaper publication of stock transfer, the completed background investigation by the Wyckoff Police Department of Mrs. Hafi Kastrati & the subsequent police report the municipal clerk submitted the change of corporation structure application to the Alcoholic Beverage Control (ABC); and,

WHEREAS, the inactive status of The Brownstone liquor license commenced on May 8, 2011 the licensee as required by law petitioned the Director of the ABC for an extension of the inactive status of The Brownstone liquor license which expires in 2016 that states the liquor license of The Brownstone is for sale; and,

WHEREAS, the Municipal Clerk requested and received reports from the Police Department, Fire Prevention Bureau and Sanitarian in conjunction with the 2014-2015 annual renewal application. The licensee meets their ADA parking requirement called for on the site plan; and,

WHEREAS, the municipal Clerk and township Attorney have reviewed the submitted renewal application, fees, sketch, tax clearance certificate and reports and find them to be in proper order and the Township Attorney has consulted with the State of New Jersey Attorney General's Office and Division of ABC regarding the change of corporate structure and the township's ability to renew the license; and,

WHEREAS, no written objections have been received by the municipal clerk regarding the renewal of The Brownstone liquor license concurrent with the recent change in corporate structure submitted to the ABC on June 25, 2015 which transfers 100% of the corporate stock from Mr. Aziz Kastrati to Mrs. Hafi Kastrati; and

WHEREAS, on April 29, 2015 a letter was sent by the Township Attorney Robert E Landel to Mrs. Hafi Kastrati's Attorney Mr. Christopher T. Karounos reiterating Mrs. Hafi Kastrati's comments made during a meeting that was attended by Robert E. Landel, Esq., Christopher T. Karounos, Esq. (Attorney for Mrs. Hafi Kastrati), Municipal Clerk Joyce Santimauro, Mr. Aziz Kastrati and Mrs. Hafi Kastrati on April 29, 2015. Mrs. Hafi Kastrati stated during the April 29, 2015 meeting that both Mr. Aziz Kastrati and Mrs. Hafi Kastrati intended on maintaining ownership of the 625 Wyckoff Avenue, Wyckoff, New Jersey property. Mrs. Kastrati also confirmed that a decision to either sell the liquor license or continue to utilize and operate the liquor license would be made by December 31, 2015. Mrs. Hafi Kastrati also stated during the April 29, 2015 meeting that she would either sell the liquor license or operate out of 625 Wyckoff Avenue by June 2016 prior to the Township's renewal of the 2016-2017 liquor license renewals.

WHEREAS, as part of the application process, the governing body/board received public comments on the proposed park improvements in the application on August 4, 2015; and,

WHEREAS, the County of Bergen shall determine whether the application is complete and in conformance with the scope and intent of the County Trust Fund; and,

WHEREAS, the applicant is willing to use the County Trust Fund in accordance with such rules, regulations and applicable statues, and is willing to enter into an agreement with County of Bergen for the above named project and ensure its completion on or about the project contract expiration date.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey:

1. That it is hereby authorized to submit the above completed project application to the County; and,

2. That the Township Committee has secured the balance of funding necessary to complete the project, or modify the project as necessary; and,

3. That the Township Committee is committed to providing a dollar for dollar cash match for the project; and,

4. That only those park improvements identified and approved in the project application, its Trust Fund contract, or other documentation will be considered eligible for reimbursement.

5. That the Township Committee of the Township of Wyckoff agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project; and,

6. That this resolution shall take effect immediately.

#15-207 Property Maintenance Abatement – 469 Cedar Hill Avenue

WHEREAS, the residential home and land at 469 Cedar Hill Ave., Block 349/Lot 70 is owned by Brian Shannon; and,

WHEREAS, the Township Committee of the Township of Wyckoff has established a property maintenance code known as Chapter 152 of the Code of the Township of Wyckoff; and,

WHEREAS, all the owners of property in the Township of Wyckoff are required to comply with the provisions in Chapter 152 of the Code of the Township of Wyckoff; and,

WHEREAS, adjacent property owners and neighbors have brought property maintenance violations to the attention of the Zoning Administrator and the Zoning Administrator has issued an abatement notice in compliance with Chapter 152 to the owner and mortgagee of 469 Cedar Hill Ave. The Zoning Administrator has attempted to obtain compliance through letters and telephone calls as detailed on the attached certification with the result that the owner and mortgagee have failed to abate the violations enumerated in the abatement notice; and,

WHEREAS, the property owner has the duty to remove the violations after notice has been issued; and

WHEREAS, the Zoning Administrator has filed a certification dated July 29, 2015 (attached as if set forth at length) in compliance with Chapter 152 which certifies the cost of \$ 650.00 as the verified charge to abate certain violations; and,

WHEREAS, the attached certificate with attachments is presented to the Township Committee for their examination and if found correct, to be charged against the lands upon which the violation existed.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that they have examined the certification dated July 29, 2015 from the Zoning Administrator and find it to be correct and cause the cost of

\$ 650.00 to be charged against the land, namely Block 349/Lot 70, known as 469 Cedar Hill Ave. as a lien on the property for the cost to abate the property maintenance violation.

BE IT FURTHER RESOLVED, that the amount of \$ 650.00 charged shall become a lien upon such lands and shall be added to and become, in form, part of the taxes next to be assessed and levied upon Block 349 Lot 70, 469 Cedar hill Ave.. This amount shall bear interest at the same rate as taxes and shall be collected and enforced by the Tax Collector and in the same manner as taxes.

BE IT FURTHER RESOLVED, that the Municipal Clerk shall provide a certified copy of this resolution and certification to the property owner, the Wyckoff Tax Collector, and the Zoning Administrator.

#15-208 Authorize Acceptance of Bergen County Open Space Grant

BE IT RESOLVED, that the Mayor and Township Committee of the Township of Wyckoff wish to enter into a Bergen County Trust Fund Project Contract ("Contract") with the County of Bergen for the purpose of using a \$20,775.00 matching grant award from the 2014 Funding Round of the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund ("Trust Fund") for the municipal park project entitled "Roller Hockey Rink Resurfacing" located in Memorial Field Athletic Field at 340 Franklin Avenue, in Block 258, Lot 1.01 on the tax map of the Township of Wyckoff; and,

BE IT FURTHER RESOLVED, that the Mayor and Township Committee herby authorize Mayor Kevin J. Rooney to be a signatory to the aforesaid grant agreement Contract and Robert J. Shannon, Administrator to sign County of Bergen payment vouchers submitted pursuant to the aforementioned project; and,

BE IT FURTHER RESOLVED, that the Mayor and Township Committee hereby acknowledge that, in general, the use of this Trust Fund grant towards this approved park project must be completed by or about July 15, 2017; and,

BE IT FURTHER RESOLVED, that the Mayor and Township Committee acknowledge that the grant will be disbursed to the municipality as a reimbursement upon submittal of certified Trust Fund payment and project completion documents and municipal vouchers, invoices, proofs of payment, and other such documents as may be required by the County in accordance with the Trust Fund's requirements; and,

BE IT FURTHER RESOLVED, that the Mayor and Township Committee acknowledge that the grant disbursement to the municipality will be equivalent to fifty (50) percent of the eligible costs incurred (not to exceed total grant award) applied towards only the approved park improvements identified in the aforesaid Contract in accordance with the Trust Fund's requirements.

ORDINANCE #1778

AN ORDINANCE TO PROVIDE A CERTAIN CAPITAL IMPROVEMENT IN THE TOWNSHIP OF WYCKOFF AND TO PROVIDE FOR THE RECEIPT, ACCEPTANCE AND DEPOSIT OF GRANT FUNDS THEREFORE.

WHEREAS, the Township of Wyckoff has made an application to the Bergen County Open Space Trust Fund Municipal Program for Park Improvement and Development to receive grant funds for resurfacing of the roller hockey rink located in the Memorial Field Recreation Complex; and,

WHEREAS, the Township of Wyckoff has been advised it is the recipient of a grant in the amount of \$20,775.00 for resurfacing of the roller hockey rink in the Memorial Field Recreation Complex; and,

WHEREAS, the Township of Wyckoff shall enter into a contract with the Bergen County Open Space Trust Fund Program to participate in the receipt of grant funds made available; and,

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, County of Bergen, as follows:

SECTION 1. The Township of Wyckoff, in the County of Bergen shall proceed with the resurfacing of the roller hockey rink in the Memorial Field Recreation Complex, Block 258/Lot 1.01, with a Bergen County Open Space Trust Fund Grant of \$20,775.00.

SECTION 2. The cost of implementing said improvements in Section 1 shall be paid by the Township out of funds to be received specifically for said purpose through the Bergen County Open Space Trust Fund Grant Program.

SECTION 3. It is hereby determined and stated:

a.	Said purpose is not a current expense. The same is an Improvement which the Township of Wyckoff may lawfully
	make or acquire and no part of the cost of said improvement has
	been or shall be specifically benefited.
b.	It is not necessary to finance this authorization by the issuance of
	obligations by the Township of Wyckoff pursuant to the Local
	Bond Law of the State of New Jersey.
c.	The total authorized appropriation in the ordinance is
	\$20,775.00.

SECTION 4. The monies which the Township of Wyckoff is authorized to receive pursuant to the terms of the Bergen County Open Space Trust Fund Program, shall, when received, be placed in a capital improvement fund of the Township of Wyckoff for the purpose set forth in Section 1 of this ordinance.

SECTION 5. It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said purpose, since the gross debt of the Township of Wyckoff as defined under the Local Bond Law is not increased by this

Ordinance, and no obligations in the matter of notes or bonds are authorized by this Ordinance.

SECTION 6. This ordinance shall take effect after publication thereof and final passage as required by law.

ORDINANCE #1779

AN ORDINANCE TO AMEND CHAPTER 177 "VEHICLES AND TRAFFIC" OF THE CODE OF THE TOWNSHIP OF WYCKOFF TO ADD NEW SECTION "177-55, SPEED LIMITS ON TOWNSHIP PROPERTY," TO SET SPEED LIMITS ON CERTAIN MUNICIPAL PROPERTIES WITHIN THE TOWNSHIP OF WYCKOFF

BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, that new Section 177-55, "Speed Limits on Township Property," is added as follows:

SECTION 1

A. Speed limits are hereby established upon the following Township properties.

LOT & BLOCK	SPEED LIMIT (MPH)	LOCATION
Lot 1.01, Block 258	10	All internal roadways, driveways, and parking areas
Lot 7.03, Block 202	10	All internal roadways, driveways, and parking areas
Lot 36, Block 346	10	All internal roadways, driveways, and parking areas

B. Any violation of any provision of this Section shall subject the violator to a fine of Eighty-Five (\$85) Dollars if the violator is 1 - 9 mph over the speed limit, a fine of Ninety-Five (\$95) if the violator is 10 - 14 mph over the speed limit, and a fine of One-Hundred Five (\$105) Dollars if the violator is 15 - 19 mph over the speed limit.

SECTION 2 - Except as hereby amended, all other sections of Chapter 177 shall remain in full force and effect.

SECTION 3 - This Ordinance shall take effect upon final passage and publication according to law.

ORDINANCE #1780

AN ORDINANCE TO AMEND SECTION 186-22 OF THE CODE OF THE TOWNSHIP OF WYCKOFF "REGULATIONS APPLYING TO ALL ZONES" TO PROVIDE FOR THE REGULATION OF CONSTRUCTION TRAILERS IN COMMERCIAL ZONES WITHIN THE TOWNSHIP OF WYCKOFF

BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, that Section 186-22, "Regulations applying to all zones" is amended as follows:

SECTION 1

N. <u>Construction</u> trailers shall not be parked out of doors for more than 72 hours in any zone except for construction trailers used for office purposes in connection with construction work in the B-1, B-1A, B-2, B-3, B-5, B-5/SDAH-2, L-1 and L-2 Zones where the trailers are parked on the premises and where the work is being done during the period of construction.

<u>SECTION 2</u> - Except as hereby amended, all other sections of Section 186-22 shall remain in full force and effect.

<u>SECTION 3</u> - This Ordinance shall take effect upon final passage and publication according to law.

ORDINANCE #1781

AN ORDINANCE TO AMEND SECTION 173 OF THE CODE OF THE TOWNSHIP OF WYCKOFF "TRAILERS," TO PROVIDE FOR THE REGULATION AND LIMIT OF STORING RECREATIONAL VEHICLES, TRAILERS AND CAMP CARS WITHIN THE TOWNSHIP OF WYCKOFF

BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, that Section 173, "Trailers," is replaced with the following:

SECTION 1

Chapter 173

RECREATIONAL VEHICLES, TRAILERS AND CAMP CARS

- 173-1 Definitions
- 173-2 Permitted and prohibited use of <u>recreational vehicles</u>, trailers <u>and camp</u> <u>cars</u>
- 173-3 Violations and penalties
- 173-1. **Definitions**

As used in this chapter, the following terms shall have the meanings indicated:

<u>RECREATIONAL VEHICLE</u>, TRAILER or CAMP CAR-- Any vehicle used or intended to be used as a conveyance upon the public streets or highways and duly licensed as such, and including selfpropelled and nonselfpropelled vehicles so designed, constructed and reconstructed or added to by means of accessories in such a manner as to permit the occupancy thereof as a dwelling or sleeping place for one (1) or more persons and having no foundation other than wheels, jacks or blocks. <u>The definition of trailer shall also include noncommercial unpowered vehicles designed to be towed by other vehicles and used to carry and transport other items.</u>

173-2 **Permitted and prohibited use of <u>recreational vehicles</u>, trailers <u>and camp cars.</u>**

It shall be unlawful for any person to park any <u>recreational vehicle</u>, trailer or camp car on any street in the Township of Wyckoff or on any premises within the limits of the township except for the purposes of repair, storage, purchase of supplies or visiting. Any such recreational vehicle, trailer or camp car undergoing repairs or being stored, the owner, driver or occupant of which is purchasing supplies or visiting, shall not during such period be used by any person as a dwelling or sleeping place. <u>No more than one ungaraged recreational vehicle</u>, trailer or camp car may be stored on any single property at any one time. Such recreational vehicle, trailer or camp car must be stored behind the front of the principal structure, in the side or rear yard.

173-3 Violations and penalties.

Any person violating any of the provisions of this chapter shall, upon conviction thereof, be punishable by a fine of not more than five hundred dollars (\$500) or by imprisonment for not more than ninety (90) days, or both.

<u>SECTION 2</u> - Except as hereby amended, all other sections of Section 173 shall remain in full force and effect.

<u>SECTION 3</u> - This Ordinance shall take effect upon final passage and publication according to law.
