WHEREAS, the placement of clothing bins are provided as a public conveyance under the "police powers" of the Township through a publicly advertised competitive sealed bidding process":

- This authorization will address a public need to raise additional revenue to defray taxes and provide locations for citizens to recycle their clothing and assist the Volunteer Fire Dept . and Volunteer Ambulance Corps.
- Placement of three clothing bins on municipal property.
- The benefits of obtaining additional revenue to defray taxes and to provide in-town convenient locations outweigh the risks of not providing this opportunity to recycle.
- Total estimated annual revenue, \$8,500.
- The basis of the award will be the highest prices bid from the responsive and responsible bidder.
- No additional costs are anticipated to provide these programs.
- No endorsements shall be issued.
- Competitive sealed public bidding shall be followed to award concessions.
- This is an opportunity to recycle clothing and shoes and it is not a tax exempt donation.

WHEREAS, the Finance Committee has recommended the Township Committee authorize public bidding for the placement of these bins; and

WHEREAS, the Township Administrator and Township Attorney have reviewed NJAC 5:34-9.4 and concur with the recommendation.

#1774 - A BOND ORDINANCE AUTHORIZING VARIOUS CAPITAL IMPROVEMENTS IN, BY AND FOR THE TOWNSHIP OF WYCKOFF, IN THE COUNTY OF BERGEN, NEW JERSEY, APPROPRIATING \$1,000,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$950,000 OF BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WYCKOFF, IN THE COUNTY OF BERGEN, NEW JERSEY, THAT:

SECTION 1. There is hereby authorized, pursuant to the applicable statutes of the State of New Jersey, the improvements set forth below in, by and for the Township of Wyckoff, County of Bergen, State of New Jersey (the “Township”), together with other purposes necessary, appurtenant or incidental thereto or thereof:

SECTION 2. It is hereby determined and declared by this Township Committee as follows:

A. The estimated aggregate maximum amount of money to be raised from all sources for the purposes stated in Section 1 is \$1,000,000.00.

B. The estimated aggregate maximum amount of bonds or notes to be issued for the purposes stated in Section 1 is \$950,000.00.

C. An appropriation was or is contained in a budget or budgets of the Township heretofore adopted in the sum of \$50,000 for capital improvement purposes; there is now available in the Capital Improvement Fund said sum of \$50,000, which sum is hereby appropriated as a down payment for the purposes stated in Section 1.

SECTION 3. The sum of \$1,000,000.00, including said down payment of \$50,000, is hereby appropriated for the purposes stated in Section 1.

SECTION 4. For the purpose of financing part of the cost of the improvements described in Section 1, exclusive of said down payment, the issuance of bonds of said Township in an aggregate principal amount not exceeding Nine Hundred Fifty Thousand Dollars (\$950,000) is hereby authorized

pursuant to the provisions of the Local Bond Law, N.J.S.A. 40A:2-1 et seq. The rate or rates of interest, maturities, method of sale and other details of said bonds not determined herein shall be determined by subsequent resolution or resolutions adopted by the Township Committee pursuant to law.

SECTION 5. Pending the issuance of the bonds authorized in Section 4 hereof, bond anticipation notes of the Township may be issued pursuant to said Local Bond Law in an aggregate principal amount not exceeding Nine Hundred Fifty Thousand Dollars (\$950,000). Each such bond anticipation note shall be designated "Bond Anticipation Note." All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Township; provided that no note shall mature later than one year from its date. All such bond anticipation notes may be executed in the name of the Township by the manual or facsimile signatures of the Mayor and Chief Financial Officer or such other official of the Township as may hereafter be designated by resolution or otherwise as provided by law and shall be under the seal of the Township and attested by the Township Clerk. The notes shall bear interest at such rate or rates and shall be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8.1. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver such notes to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest, if any, from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the Township Committee at the meeting next succeeding the date when any sale or delivery of notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser or purchasers thereof.

SECTION 6. It is hereby further determined and declared by this Township Committee as follows:

A. The improvements or purposes described in Section 1 are not current expenses; they are improvements or purposes that the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

B. The weighted average period of usefulness for the purposes described in Section 1 for which the bonds are hereby authorized to be issued, within the limits prescribed by the Local Bond Law, is 10.32 years.

C. All bonds or notes issued pursuant to this ordinance shall bear interest at a rate not to exceed the maximum rate permitted by law.

D. The supplemental debt statement required by said Local Bond Law has been duly made and filed in the office of the Township Clerk prior to the passage of this ordinance on first reading, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey prior to the passage of this ordinance on final reading, and such statement shows that the gross debt of said Township, as defined in N.J.S.A. 40A:2-43, is increased by this ordinance by \$950,000 and that the issuance of the obligations authorized by this ordinance will be within all debt limitations contained in the Local Bond Law.

E. The aggregate amount of the proceeds of the obligations authorized by this ordinance to be expended for interest on the obligations authorized herein, engineering and inspection costs, legal expenses, and the costs of issuance of the obligations authorized by this ordinance, including printing, advertisement of ordinances and notices of sale and legal expenses, and other expenses as provided in N.J.S.A. 40A:2-20 does not exceed \$0.

SECTION 7. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith, and the resolutions promulgated by the Local Finance Board showing full

detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

SECTION 8. In the event that any other moneys are lawfully received from any source for the purposes provided in this ordinance, such moneys shall be used for the purposes authorized herein and to reduce the amount of bonds or notes authorized to be issued by this ordinance by the amount so received, or if such other moneys are received after the issuance of the bonds or notes authorized by this ordinance, such moneys shall be used solely for the payment of the debt service on said bonds or notes as the same become due and payable.

SECTION 9. The full faith and credit of the Township is hereby pledged for the payment of the principal of and interest on all bonds and notes issued pursuant to this ordinance, and as long as such bonds or notes are outstanding there shall be levied in each year *ad valorem* taxes on all taxable property within said Township, without limitation as to rate or amount, sufficient to pay the principal of and interest on such bonds and notes maturing in said year.

SECTION 10. (a) The Township shall comply with all provisions of the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder or applicable thereto (the "Code") applicable to the bonds or notes issued pursuant to this bond ordinance and shall not take any action, or fail to take any action, if any such action or failure to take action would cause interest on the bonds or notes issued pursuant to this bond ordinance to be or become includable in gross income under Section 103 of the Code or cause interest on the bonds or notes issued pursuant to this bond ordinance to be treated as an item of tax preference under Section 57 of the Code. The Township shall not directly or indirectly use or permit the use of any proceeds of such obligations or any other funds of the Township, or take or omit to take any action, that would cause such obligations to be "arbitrage bonds" within the meaning of Section 148(a) of the Code, and will comply with all requirements of Section 148 of the Code to the extent applicable to the bonds and notes authorized hereby and all proceeds thereof, including without limitation, monitoring compliance with Section 148 of the Code as it applies to the bonds and notes authorized hereby, restricting the yield on the investment of any proceeds or gross proceeds of the bonds or notes to the extent required to comply with Section 148 of the Code, and making payments of the rebate amount, if any, to the United States in the manner and to the extent necessary to comply with Section 148 of the Code.

(b) The Township reasonably expects to reimburse the Township's expenditure of certain costs of the improvements or purposes described in Section 1 of this bond ordinance ("Project Costs") incurred and paid prior to the issuance of any bonds or notes authorized by this bond ordinance with the proceeds of such bonds or notes. This Section is intended to be and hereby is a declaration of the Township's official intent to reimburse any expenditure of Project Costs incurred and paid prior to the issuance of bonds or notes authorized herein with the proceeds of such bonds or notes in accordance with Treasury Regulations Section 1.150-2(e), and no reimbursement allocation will employ an abusive arbitrage device under Treasury Regulations Section 1.148-10 to avoid the arbitrage restrictions. The maximum principal amount of obligations expected to be issued pursuant to this bond ordinance to pay Project Costs does not exceed \$950,000. The Project Costs to be reimbursed with the proceeds of the bonds or notes authorized herein will be "capital expenditures" as defined in Treasury Regulations Section 1.150-1(b), a cost of issuance for the bonds or notes herein authorized or an expenditure described in Treasury Regulations Section 1.148-6(d)(3)(ii)(B). The allocation of proceeds of the bonds or notes issued pursuant to this bond ordinance to reimburse Project Costs incurred prior to the issuance of such bonds or notes shall be effected no later than 18 months after the later of the date the Project Costs are paid or the date the improvements are placed in service or abandoned, but in no event more than 3 years after the original Project Costs to be reimbursed are paid.

SECTION 11. This ordinance shall take effect twenty days after the first publication hereof after final adoption, in the manner provided by law.

#15-154 Authorize Contract to Pave Roads

WHEREAS, Ordinance #1100 authorized participation in a cooperative pricing system with municipalities in Northwest Bergen County; and,

WHEREAS, the Township of Wyckoff is a current member of the Northwest Bergen Cooperative Pricing System; and,

WHEREAS, the Township of Wyckoff suffered a very severe winter which fell 49.5 inches of snow and required the DPW to respond to twenty (20) snow/ice emergencies; and,

WHEREAS, this winter's fluctuating temperatures between freezing and warm with rain and ice deteriorated many of Wyckoff's asphalt roads; and,

WHEREAS, the Township Committee of the Township of Wyckoff determined that the responsible course of action would be to increase the Township's road resurfacing appropriation to counter the negative effects that resulted to Wyckoff roads due to this winter's weather; and,

WHEREAS, funds are not unlimited and the Township cannot pave every road, requiring difficult choices among valid requests; and,

WHEREAS, consistent with past practices, the Township Committee relies on the professional opinion of the Township Engineer, Public Works Manager and Chief of Police to determine the roads most in need of repair; and,

WHEREAS, the Township Committee desires to pave the most roads in need of repair and therefore authorized bidding through the Northwest Bergen Cooperative Pricing System aggregating the volume of work with many other municipalities to obtain discount volume pricing and on 4/14/15 authorized a separate Wyckoff procurement for road resurfacing in accordance with N.J.S.A. 5:34-7.20 providing the Township of Wyckoff with the flexibility of two (2) advertised competitive bidding opportunities to obtain the most competitive price for our taxpayers; and,

WHEREAS, a public notice soliciting bids for the Township of Wyckoff's procurement was advertised on 4/17/15 in the Ridgewood News and posted on the Township's website under the easily accessed quick link on the homepage titled, Bids and Jobs, and specifications were provided at no cost to encourage competition; and,

WHEREAS, eight (8) potential bidders obtained copies of the bid specifications free of charge to encourage bidding; and,

WHEREAS, on 5/1/15 at 11:00 a.m. the Township received eight (8) sealed bids which were opened and their contents read aloud as reflected in the attached minutes of the bid opening prepared by the Municipal Clerk; and,

WHEREAS, the Borough of Ramsey (the lead agency for the Northwest Bergen Cooperative Pricing System) has complied with the Local Public Contracts Law and publicly advertised, received, opened and read the bids as indicated on the attached summary sheet; and,

WHEREAS, the unit price per ton of asphalt from the regional Northwest Bergen Cooperative Pricing Competitive low bidder is \$76.15 per ton installed; and,

WHEREAS, the significance of this strategic procurement result is an additional \$13,000 available for road resurfacing due to the favorable competitive unit price; and,

WHEREAS, the Township of Wyckoff shall advise the Cooperative Pricing System that it shall withdraw its estimate from the Cooperative Pricing bid because the Township captured a lower unit price through the Wyckoff advertised competitive procurement; and,

WHEREAS, the Chief Financial Officer has issued a certificate attached to this resolution which indicates that available funds are subject to the adoption of 2015 Capital Ordinance #1774.

SECTION 1. The rate of compensation of each officer and Town Hall employee of the Township of Wyckoff for the year 2015 whose compensation shall be on an annual basis within the range, and shall be paid semi-monthly, is as follows:

Township Clerk.....up to 35,506

- f. During the sixteenth year.....18 working days/year
- g. During the seventeenth year.....19 working days/year
- h. During the eighteenth year.....20 working days/year
- i. During the nineteenth year.....23 working days/year
- j. During the twentieth year.....24 working days/year
- k. During the twenty first year
and each year thereafter.....25 working days/year

SECTION 5. All salaries and compensation provided for full time employees provided for herein shall be retroactive to January 1, 2015. All 2015 salaries and compensation for part time employees hired on or before June 30 of the prior year will receive retroactive compensation to January 1, 2015, provided they continue to be employed with the Township on July 1, 2015.

AN ORDINANCE AUTHORIZING THE APPROPRIATION OF \$277,775 FOR IMPROVEMENTS OR PURPOSES AUTHORIZED TO BE UNDERTAKEN BY THE TOWNSHIP OF WYCKOFF, COUNTY OF BERGEN, STATE OF NEW JERSEY, AND PROVIDING THE NECESSARY FUNDS THEREFORE

BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, in the County of Bergen, State of New Jersey as follows:

Section 1. The improvements described in Section 3 of this ordinance are hereby authorized by the Township of Wyckoff, and there is hereby appropriated the sum of money herein stated as the appropriations made therefore and amounting to \$277,775.00.

Section 2. For the financing of said improvements, and to meet the cost therefore, there is hereby appropriated from the Capital Improvement Fund for the Township of Wyckoff, the said sum, being available by virtue of a provision included in the approved 2015 Municipal Budget.

Section 3. The improvements authorized and the appropriations therefore are for the purchase of Department of Public Works equipment, road resurfacing, engineering services for road and facility improvements, improvements to public buildings and facilities, purchase of safety equipment for firefighters, purchase recreation program equipment, Fire Chief command vehicle, park and recreation area enhancements, various Town Hall and Public Works complex improvements, public safety equipment, police patrol SUV, police server & radio upgrade, traffic safety signs & safety signals, purchase finance computer server, recreation field improvements and various other capital improvements.

Section 4. This Ordinance shall take effect immediately upon final passage and publication according to law.

1. Goran Vukobratovic 622 Lawlins Road, Wyckoff, New Jersey - Mr. Vukobratovic expressed his disappointment with the police report and the description of events in the report. Mr. Vukobratovic stated he does not know how to move forward without a true description of events. He stated if we do not agree with what really happened we cannot move forward. He said he is receiving hundreds of cards, letters and calls from all over saying don't give up.

2. Helena Vallonchini, 293 Doremus Avenue, Glen Rock, New Jersey - Ms. Vallonchini stated that her heart is saddened with the loss of Otto the dog and in such a tragic way. She stated she cannot comprehend how the Township Committee can exonerate this officer when the officer is told by the dispatcher that the incident happened a few days before. She further stated there was no reason to go to the house let alone the wrong address. Ms. Vallonchini stated she must bring up the past saying; this officer killed someone in Newark, she asked how can he be kept on the Wyckoff Police force as he is a "killer Cop." This is the second time he used a lethal weapon. What will be the third time? For the sake of the family, residents of Wyckoff and non-residents of Wyckoff please, do not keep this officer, she asked.

3. SueEllen Jelttes, 31 Minnehaha, Oakland, New Jersey - Mrs. Jelttes stated that she works for the Township of Wyckoff and has been here working since 1991. Her son is a police officer in the state of Colorado and she knows many police officers. She stated she attended a funeral service for a police officer friend of her son in Colorado and her heart is with our police officer's safety. She further stated that the family's questions do not diminish her respect for our police officers. Last year the Township sent inspectors in every home to perform a revaluation. She said, we had one incident of a vicious resident but no reports of a vicious dog. She stated whatever missteps occurred what scares her is that the officer fired four shots. She further stated the family found three casings in their yard. Her son, a police officer in Colorado must account for every casing and bullet by Colorado law when a gun is discharged, she said. Wyckoff in New Jersey does not have this policy she said. Mrs. Jelttes said she would be at work tomorrow and hoped to be treated with the same amount of respect that Chief Fox is given.

4. Robert Lehmann, 52 Saxonia, Wyckoff, New Jersey - Mr. Lehmann reminded the Township Committee that he owns a dog and is involved in animal rescue; he further stated that his father was a Chief of Police. Mr. Lehmann told the Township Committee it is not making it easy. Two weeks ago he was here, he said and asked for two things; the first was a transparent investigation and the second was training for police officers when encountering dogs. He suggested that neither have happened. The Wyckoff Police Department decided to investigate itself rather than using a third party, he said. He further stated no transparency was present. He suggested the dispatch recording was edited and we have no idea what was cut out. Statements were not released, no bite marks on the boot were produced and no investigators talked to the victims. What did they investigate he asked. He stated the Police Department version seems at odds with multiple eyewitness accounts.

Mr. Lehmann questioned if the police officer knocked on the door why didn't the guard dog bark? Mr. Lehmann further questioned if it is protocol to investigate a scene and obtain the ballistics. When the officer fired his weapon at this point it seems that unless the Bergen County Prosecutor or State Attorney General steps in we have a report that holds very little water and the water it holds is tainted he said. Mr. Lehmann stated he had hoped that the police department would have initiated training. The police department seems to want to lay the blame on the Bergen County Central Dispatch System, he added. This police department needs police and police dog training, Mr. Lehmann suggested many cities and municipalities across the county have mandated this training. In his opinion he said, Wyckoff should do it and be the first municipality in New Jersey to provide police officer training for encounters with dogs. Mr. Lehmann suggested this would ensure residents with pets would feel at ease and show that the Wyckoff Police Officers are willing to learn from this tragedy. Mr. Lehmann suggested that this training is not very expensive and he would see to it that it would be provided without any expense to Wyckoff taxpayers. Mr. Lehmann stated he does not leave his dog in his yard for fear of coyotes and bears, however; he never thought he would have to fear the Wyckoff Police. Mr.

Lehmann hopes that the Township Committee and Wyckoff Police Department could restore that trust.

5. Chris Scala, 2294 Oakham Court, Mahwah, New Jersey - Mr. Scala stated that we the people of this community and its neighbors demand human decency and respect. He stated the town has deceived the public; this is not about politics. This investigation was not handled with proper investigatory procedures, he said. He further stated this armed police force carelessly could endanger our lives and our pets. He stated Chief Fox stated the officer was attacked without even investigating a piece of evidence to the contrary. Witnesses submitted verbal and written statements that day, he said. He further stated that Chief Fox ignores that one witness who stated with complete confidence Otto did not attack the police officer. Why was that statement left out of Chief Fox's letter he asked Mr. Scala stated statements which questioned the police officer's account of events as well as the police actions regarding police investigatory actions. He further stated no one has demonstrated to us how this occurrence will be prevented and not falsified which only proves it can and will happen again. Mr. Scala requested the police show us that they are not only responsible police officers deserving of their large salaries and permits to carry fire arms, but that they are decent human beings.

6. Doug Dial, 502 Berkley Drive, Wyckoff, New Jersey – Mr. Dial stated that he had the privilege of serving as Mayor years ago and he would like to change the subject from dogs to cats. One evening such as this the Township Committee had a room full of people similar to this with placards and balloons objecting to an ordinance which would require the vaccination of cats. He recalled a rabies epidemic had just spread up the East Coast and health departments in multiple states had issued a health warning alerting municipalities regarding the spread of rabies from dogs and cats to people. Mr. Dial stated that at that meeting such comments were made that included how will we know the vaccines will not hurt our cats; one person suggested vaccinating our children rather than our cats, another person suggested dropping food pellets from an airplane laced with rabies vaccine the theory that the wild animals would eat the food pellets and vaccinate themselves. Mr. Dial suggested that this evening had similar exaggerated rhetoric. What is next in this trail of exaggerated rhetoric, he asked. Do we have to give our fireman training when they enter house not to knock over a tank of tropical fish? Mr. Dial indicated several speakers have pointed out the superb job our police officers provide. A dog biting a police officer is a rare occurrence, however; the likelihood of a police officer being attacked by a teenager high on heroin or methamphetamine is not so remote. Instead of lavishing all this attention and energy on pets if our citizens refocused their attention and would lavish supervision and concern over their children, it would be a much more beneficial use of their time and energy, Mr. Dial said.

7. Steve Deysher, 1409 Ridge Road, Mahwah, New Jersey - Mr. Deysher stated that he was appealing to the Township Committee member's hearts and good nature. He asked the governing body what they would do if this was its dog? He suggested the Township Committee should not abdicate their responsibility and hide behind rules of order and decorum. He asked what you will do about the police conducting an investigation without transparency. He stated he comes from a police officer family his uncle is a Sergeant in the Jersey City Police Department where there is actual danger. He further stated he has never seen his uncle harm a dog where there are pit bulls on the streets that he patrols. He asked the governing body to explain the investigation.

8. Richard Thomas, 170 East Ridgewood Ave, Ridgewood, New Jersey – Mr. Thomas asked the Township Committee a series of questions which focused on: whether a thorough and transparent investigation was performed, did the officer's statements support the evidence. Was there another option to use instead of firing his weapon? Why weren't the casings retrieved by the police? What
