Meeting Called To Order

Mayor Rudolf E. Boonstra called the regular meeting of the Wyckoff Township Committee in the Municipal Court Room to order at 8:00 pm.

Flag Salute

The Township Committee proceeded with the Pledge of Allegiance led by Mayor Rudolf E. Boonstra.

Invocation

The Invocation was given by Pastor Wesley Kenyon from Wyckoff Assembly of God Church

Attendance

Open Public Meeting Act Statement

Municipal Clerk Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

Mr. Stephen Joern, 363 Butternut Avenue. Mr. Joern said that he is a 46 year resident, he served on the Board of Adjustment and Planning Board, he was appointed by Hank McNamara, and he campaigned for Rudy Boonstra when he was on the school board and Brian Scanlan for Township Committee. He was interested for himself and other residents in town about the tradition of selecting the Mayor for 2017.

Mr. Joern opined that Brian Scanlan has been a top vote getter in the last 8 years. He referenced a general election where he said Brian Scanlan received 10,300 votes overall; he was 20 over his closest competitor; 43% over the next person, 128% over the next 4 people; 186% over the next 2 people; and 415% over the last 4 people. Mr. Joern said that he and other residents assumed Brian Scanlan would be appointed Mayor in 2017, since in 2016 he was Deputy Mayor.

Mayor Boonstra said that two (2) years ago he was deputy mayor, but not appointed mayor; and that years ago there were other instances of the same situation.

Mayor Boonstra asked for comments from the committee.

Mr. Joern concluded by saying that we should remind ourselves that Wyckoff is not a private kingdom of any political party, or person, or old boy network, and not appointing Brian Scanlan to be mayor deters him from running again.

Mayor Boonstra said thank you to Mr. Joern for his comments.

Mayor Boonstra said: "The Wyckoff Township Committee would like to announce the hiring of Probationary Patrol Officer Kaitlyn N. Maglione. Kaitlyn graduated from the Bergen County Law and Public Safety Institute Alternate Route program on December 15, 2016. Kaitlyn follows a legacy of police officers as both of her parents are retired Sergeants who served long careers in the Ridgefield Park Police Department.

Kaitlyn graduated in 2006 from Immaculate Conception High School in Lodi as the Salutatorian of her class. She attended Mount Saint Mary College in Newburgh NY, where she was awarded a Bachelor of Arts Degree and graduated Magna Cum Laude. Kaitlyn ranked 22 out of 426 students and graduated with a GPA of 3.74. She was on the Dean's list for 5 semesters and earned the Aquinas Scholar award during the 2008 -2009 spring semester. Kaitlyn continued her education and enrolled at Rutgers University School of Social Work in New Brunswick in the fall of 2010. She graduated in May of 2012 and was awarded a Master's Degree in Social Work. She also earned a certificate in Violence Against Women and Children. She earned a total of 60 credits at Rutgers and graduated with a cumulative GPA of 3.96.

Kaitlyn was employed at the YWCA of Bergen County. Specifically, she was part of the rape crisis center. Among her responsibilities was the supervision of the 24 hour sexual violence hotline, answering hotline calls, responding in person to those in need of assistance, and the management of grants.

Kaitlyn will be a great addition to the Wyckoff Police force and we all are looking forward to watching her future career."
